

# XKFO Universal Remote Key User Manual



### Overview:

XKFO Universal Remote Key is suitable for vehicle which contains the Xhorse receiver.

Note: The operating temperature of the product is -20–50°C.

### Button description:



Item	Description
1	Switch button for mechanical key
2	Lock button of car
3	Trunk button of car
4	Unlock button of car
5	Panic button of car

### Change battery:

First use or when the battery runs out need to change new battery, following steps:



Break open the back side plastic cover  
to open the remote



Take the battery out and replace  
new one

Note: The battery type is 2032  
with 3V, ensure the positive and  
negative of battery is correct.



Install the key same as before

### Pairing method:

Pairing with vehicle: Referring to the corresponding vehicle models to match.
