Permanent Confidentiality:

Tarana Wireless requests the exhibits listed above as permanently confidential be permanently withheld from public review due to materials that contain trade secrets and proprietary information not customarily released to the public.

The competition in this field is very intense and competitors could get an unfair advantage by accessing the information listed above. We believe that we have implemented groundbreaking solutions and designs into our backhaul product compared to anything else currently available in the market. The listed Exhibits/Items need to be protected from disclosure to our competitors in the industry. We regard these Exhibits/Items to be our intellectual property and therefore as confidential information.

This information is not accessible even for our customers or partners unless non-disclosure agreements for particular item(s) have been signed. Confidential product information can be found in, but not necessarily limited to, internal photos of the product, block diagrams, schematics diagrams, and parts lists as well as certain documents, such as the user's manuals. These documents can only be accessible by the customers

who purchase our product and accept the conditions and therefore are provided with unique information access tools.

All our products are installed in restricted places and will not be accessible to the general public. Installation requires special training of professional installers. The product is a fully integrated radio and there are no field replaceable parts. The product can only be repaired by Tarana Wireless and has tamper seals. Please refer to the User Manual Sections 1.4 which explains breaking the tamper seals voids the warranty. We therefore request that internal photos / individual modules within our product should not be revealed to the public.

Short-Term Confidentiality:

Tarana Wireless requests the exhibits selected above as short term confidential be withheld from public view for a period of 180 days from the date of the Grant of Equipment Authorization and prior to marketing. This is to avoid premature release of sensitive information prior to marketing or release of the product to the public.

The applicant understands that until such time that FCC distinguishes between Short Term and Permanent Confidentiality, either type of marked exhibit above will simply be marked Confidential when submitted to FCC.
