2 Re-use of Measured Data

2.1 Introduction Section

This application re-uses data collected on a similar device. The subject device of this application (Model: XT2231-2, FCC ID: IHDT56AC3) is electrically identical to the reference device (Model: XT2231-1, XT2231-5, FCC ID: IHDT56AC2) for the portions of the circuitry corresponding to the data being re-used. Based on their similarity, the FCC Part 15C, 15E, 22, 24, 27 reuse the original model's result and do spot-check, following the FCC KDB 484596 D01 v01.

The applicant takes full responsibility that the test data as referenced in this report represent compliance for this FCC ID: IHDT56AC3 .

2.2 Model Difference Information

The **main** difference between FCC ID: IHDT56AC2 and FCC ID: IHDT56AC3 is as below:

- Remove WCDMA Band IV and LTE Band 2/4/13/26/66.
- Add NFC and LTE Band 41

Conclusion:

Radiated spurious emission test against the variant model based on the worst-case condition from the original model was performed in this filing to demonstrate the test data from original model remains representative for the variant model.

Based on the spot check test result, the test data from the original model is representative for the variant model. The power level and RSE spot check are shown within expected level compliant to limit line.

We are using power and ERP/EIRP measurements from the original parent model reports to list on the grant.

We confirm that the test data reuse policy of FCC KDB 484596 D01 Referencing Test Data v01 has been followed and the test data as referenced from the parent model report represents compliance with new FCC ID.
