When performing measurements at a distance other than that specified, the results shall be extrapolated to the specified distance using an extrapolation factor of 20 dB/decade (inverse of linear distance for field-strength measurements, inverse of linear distance-squared for power-density measurements).
- Note 2: Test distance for frequencies at below 30 MHz, measurements may be performed at a distance closer than the EUT limit distance; however, an attempt should be made to avoid making measurements in the near field. When performing measurements below 30 MHz at a closer distance than the limit distance, the results shall be extrapolated to the specified distance by either making measurements at a minimum of two or more distances on at least one radial to determine the proper extrapolation factor or by using the square of an inverse linear distance extrapolation factor (40 dB/decade). The test report shall specify the extrapolation method used to determine compliance of the EUT.
