1. RF EXPOSURE

1.1.The Requirement

System operating under the provisions of this section shall be operated in a manner that ensures that the public is not exposed to radio frequency energy levels in excess of the Commission's guidelines. See Section 15.247(b)(4) and Section 1.1307(b)(1)

1.3.MPE Calculation Method

Predication of MPE limit at a given distance

Equation from page 18 of OET Bulletin 65, Edition 97-01

$$S=PG/4\pi R^2$$

Where: S=power density

P=power input to antenna

G=power gain of the antenna in the direction of interest relative to an isotropic radiator

R=distance to the center of radiation of the antenna

From the peak EUT RF output power, the minimum mobile separation distance, $d=0.2\text{m}$, as well as the gain of the antenna is 2.5 dBi, the RF power density can be obtained.

1.5.FCC Radiation Exposure Statement
