Test Procedure:	1. Set the spectrum analyzer or EMI receiver span to view the entire emission bandwidth. 2. Set RBW = 1MHz, VBW $\geq 3 \times$ RBW, Sweep time = Auto, Detector = RMS. 3. Allow the sweeps to continue until the trace stabilizes. 4. Use the peak marker function to determine the maximum amplitude level. 5. The E.I.R.P spectral density used radiated test method. At a test site that has been validated using the procedures of ANSI C63.4 or the latest CISPR 16-1-4 for measurements above 1 GHz, so as to simulate a near free-space environment.
