

Type-C cable

- Charging the portable Power bank
 Using your mobile phone's USB adapter. Connect a USB cable to your phone's USB adapter. Using the Type-C connector, connect the other end of the USB cable to the IN port on the portable Power bank. Plug the USB adapter into the outlet to begin charging.
- 2. Charging mobile phones and other electronic devices with
- a. Connect to USB cable to your mobile phone/device using the appropriate connector. Connect the other end of the USB cable to the OUT port of the portable Power bank. Your mobile phone/device should display the status of charging.
 b. Remove the USB cable from your mobile device when it is fully charged.
- 3. Charging mobile phones and other electronic devices with wireless output.

To use the wireless charging mode the mobile device needs to be a Qi-enabled device. If necessary, enable wireless charging in the settings of your mobile device. Next simply stick your device to the charging area and the wireless charging will start.

Note: In order to charge device use only accessory cable (provided with power bank) or the cable included with your own device by the manufacturer
