

4.2 Test Procedure

Test step			
The E.U.T and simulators are connected to the main power through a line impedance stabilization network (L.I.S.N.). This provides a 50ohm/50uH coupling impedance for the measuring equipment.			
2. The peripheral devices are also connected to the main power through a LISN that provides a 50ohm/50uH coupling impedance with 50ohm termination. (Please refer to the block diagram of the test setup and photographs).			
3. Both sides of A.C. line are checked for maximum conducted interference. In order to find the maximum emission, the relative positions of equipment and all of the interface cables must be changed according to ANSI C63.10 on conducted measurement.			
1. The EUT was placed on the tabletop of a rotating table 0.8 m the ground at a 3 m semi anechoic chamber. The measurement distance from the EUT to the receiving antenna is 3 m.			
 EUT works in each mode of operation that needs to be tested, and having the EUT continuously working, respectively on 3 axis (X, Y & Z) and considered typical configuration to obtain worst position. The highest signal levels relative to the limit shall be determined by rotating the EUT from 0° to 360° and with varying the measurement antenna height between 1 m and 4 m in vertical and horizontal polarizations. Open the test software to control the test antenna and test turntable. Perform 			
 the test, save the test results, and export the test data. The antenna port of EUT was connected to the RF port of the spectrum analyzer through an RF cable. The EUT is keeping in continuous transmission mode and tested in all modulation modes. The test data is saved by the screenshot function of the spectrum analyzer.

5.1 Summary

5.1.1 Clause and Data Summary

This report is revised according to the JYTSZ-R12-2301308 report, FCC ID: 2ADYY-KJ6 issued by JianYan Testing Group Shenzhen Co., Ltd. Differences: Dual card to single card, change the SIM card seat, by replacing the software and card to achieve, PCBA has not changed. Add bands 13 and 26 by modifying software and changing component suppliers for U3220, U3314, U3024, U6603, and U3305, so no need to retest.
