





(A) Radiated Emission Test-Up Frequency Below 30MHz




(B) Radiated Emission Test-Up Frequency 30MHz~1GHz

- d. - e. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
- f. If the emission level of the EUT in peak mode was 10dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. 
