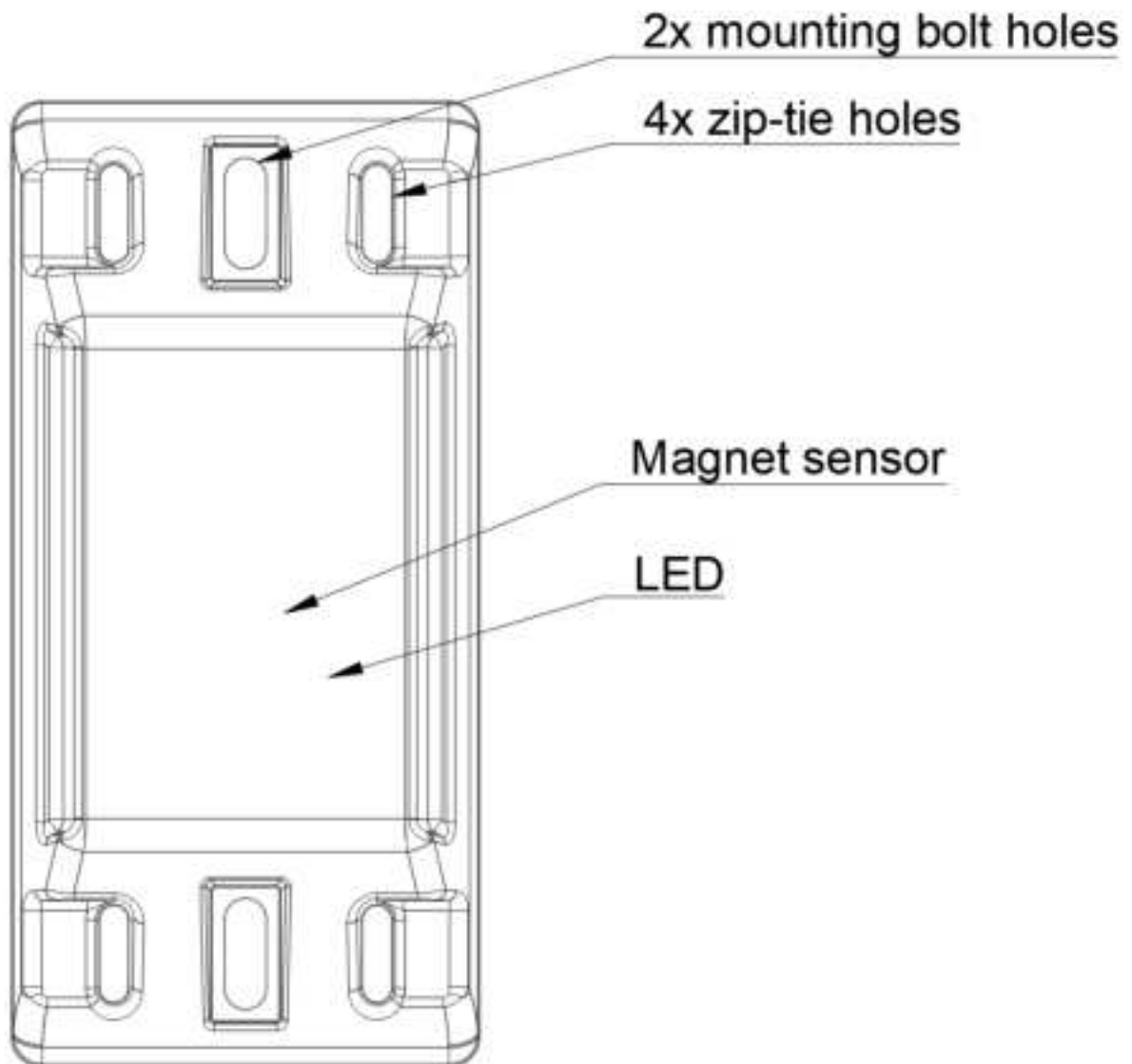

Backplate dimensions

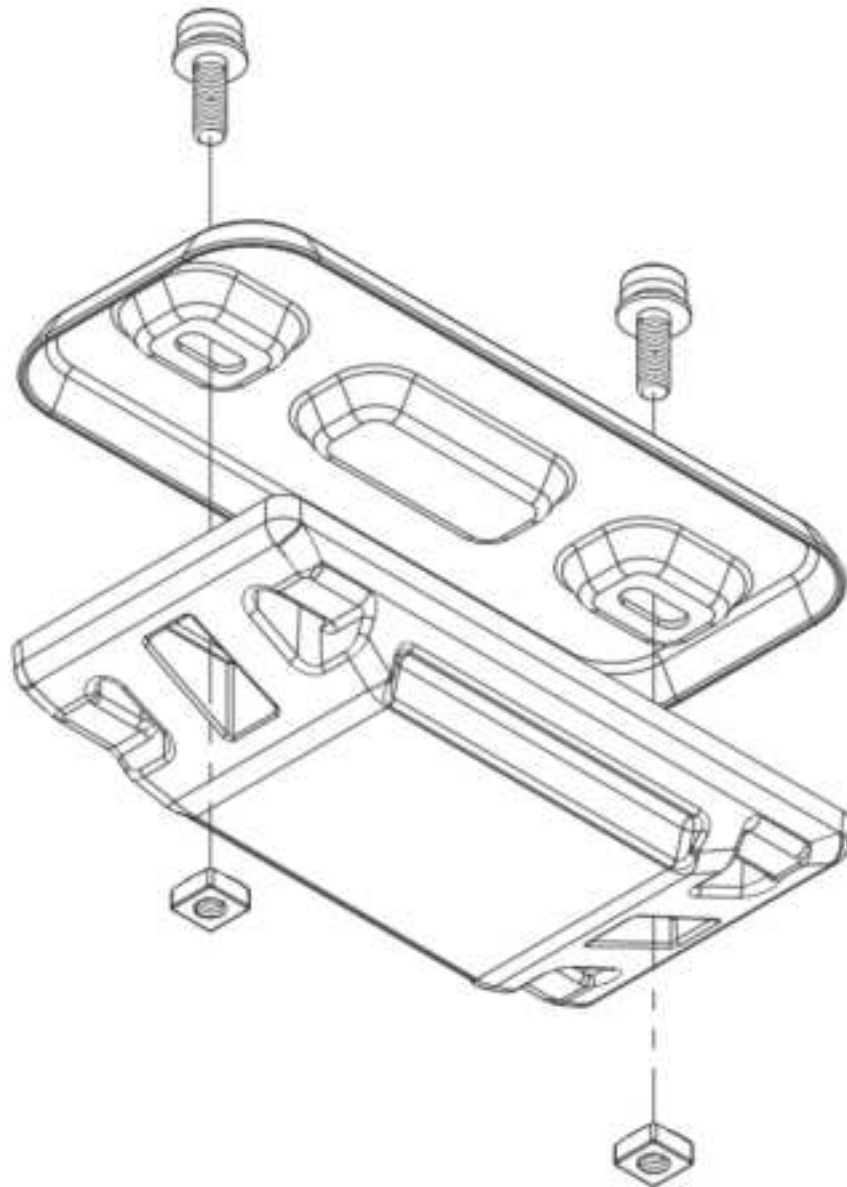

Installation

Activating the tag for the first time.

1. To activate the tag for the first time, wave a magnet over the top of the tag until an LED flashes once.
2. After the tag has been activated, the tag is ready to be configured in the Walkbase Cloud management tools.
