## 5.1 RF Exposure Compliance Requirement for FCC

#### **5.1.1 Limits**

According to FCC Part1.1310: The criteria listed in the following table shall be used to evaluate the environment impact of human exposure to radio frequency (RF) radiation as specified in part1.1307(b)

Friis Formula

Friis transmission formula:  $Pd = (Pout*G)/(4*Pi*R^2)$ 

Where

Pd = power density in mW/cm2

Pout = output power to antenna in mW

G = gain of antenna in linear scale

Pi = 3.1416

R = distance between observation point and center of the radiator in cm

Pd id the limit of MPE, 1 mW/cm2 . If we know the maximum gain of the antenna and the total power input to the antenna, through the calculation, we will know the distance r where the MPE limit is reached.

## 5.2 RF Exposure Compliance Requirement for IC

#### 5.2.1 Exemption from Routine Evaluation Limits – RF Exposure Evaluation

RF exposure evaluation is required if the separation distance between the user and/or bystander and the device's radiating element is greater than 20 cm, except when the device operates as follows:

at or above 300 MHz and below 6 GHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than 1.31 x  $10^{-2} f^{0.6834}$  W (adjusted for tune-up tolerance), where f is in MHz; RF exposure evaluation exempted power for Zigbee: 2.73W

The Max. e.i.r.p. for Zigbee: 17.25 dBm = 0.053 W

The Zigbee e.i.r.p. is less than the RF exposure evaluation exempted power. So RF exposure evaluation is not required.
