
















Fig.3 EUT Back side to flat phantom

Body - distance between flat phantom and EUT is 0 mm & 14 mm & 16 mm






Fig.4 EUT Back side (14mm) to flat phantom






Fig.8 EUT Right side to flat phantom




Fig.12 Antenna position of EUT
