

It is also intended to prevent coupling between the RF circuitry of the module and any wires or circuits in the device into which the module is installed. The module contains a backside ferrite shield (Würth WE-FSFS Flexible Ferritfolie 364002 or comparable). The shielding is designed to absorb RF radiation for areas where no radiation is intended. Additional it passed the part 15 FCC.

The length of these lines shall be length typical of actual use or, if that length is unknown, at least 10 centimeters to insure that there is no coupling between the case of the module and supporting equipment.
