

Installation & Connection


Powering On the Speaker

Step 1: Locate the silicone cover on the side of the speaker. Gently lift the silicone flap to reveal the power switch and charging port.

Step 2: Toggle the power switch to the "ON" position.

The speaker will play a start-up sound effect to indicate it is powered on.

The LED indicator lights will begin flashing, signaling the device is in pairing mode.



Wireless Pairing Instructions

Step 1: Set your mobile device to search for wireless devices.

Step 2: Search for available devices in your wireless settings. Select [4SO073A--YZ25] from the list.

Note: The default device name is printed on the product label.


Step 3: Once connected, you will hear a confirmation tone, and the LED lights will stabilize.

Step 4: Start playing audio from your device. The sound will now stream through the speaker.

Important Notes

Charging:

Use the included USB cable to charge the speaker. Connect it to a 5V adapter or computer port.



Safety Tips:

Charge the speaker fully before first use.

Avoid exposing the charging port to water or dust. Close the silicone cover when not in use.

Keep the speaker within a 10-meter (33-foot) range of your wireless device for optimal connectivity.

Troubleshooting

No Power: Ensure the switch is toggled to "ON" and the battery is charged.

Wireless Connection Failed: Turn the speaker off and on to reset pairing mode. Delete the speaker from your device's wireless list and reconnect.

Poor Audio Quality: Reduce distance from the device or eliminate obstructions.

Precautions

- Do not use in high-temperature, humid, or strong magnetic environments.
- Avoid heavy pressure or dropping the devices.
- Dispose of used batteries per local environmental regulations.

Proper Handling:

Proper Storage:

Store in a cool, dry, well-ventilated area. Keep away from heat and direct sunlight.

Disposal considerations:

If exposed to the battery – potential health effect and first aid measures:

After eye contact:

Flush eyes cautiously with plenty of water for several minutes while holding eyelids open. Remove contact lenses, if present and easy to do. Continue rinsing. Get medical attention if irritation persists.

After skin contact:

Remove contaminated clothing and shoes. Immediately wash with water and soap and rinse thoroughly. Wash clothing and shoes before reuse. If irritation occurs, get medical attention.

After inhalation:

Remove person to fresh air and keep comfortable for breathing. Administer artificial respiration if breathing is difficult. Seek medical attention.

After swallowing:

Rinse mouth with water. Do not induce vomiting. Get medical attention.
