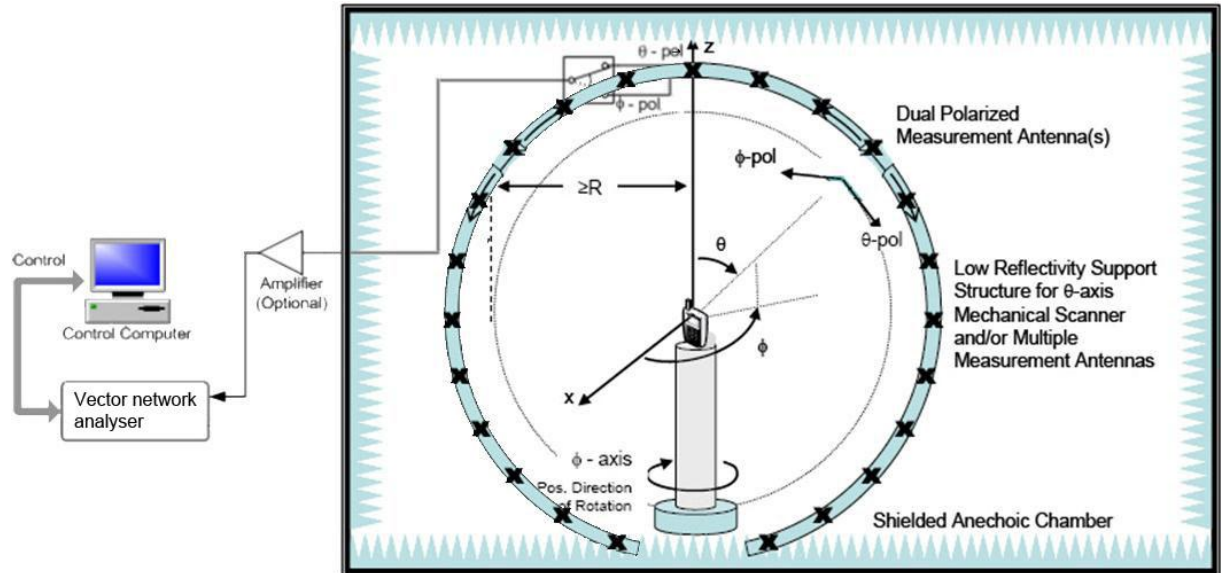

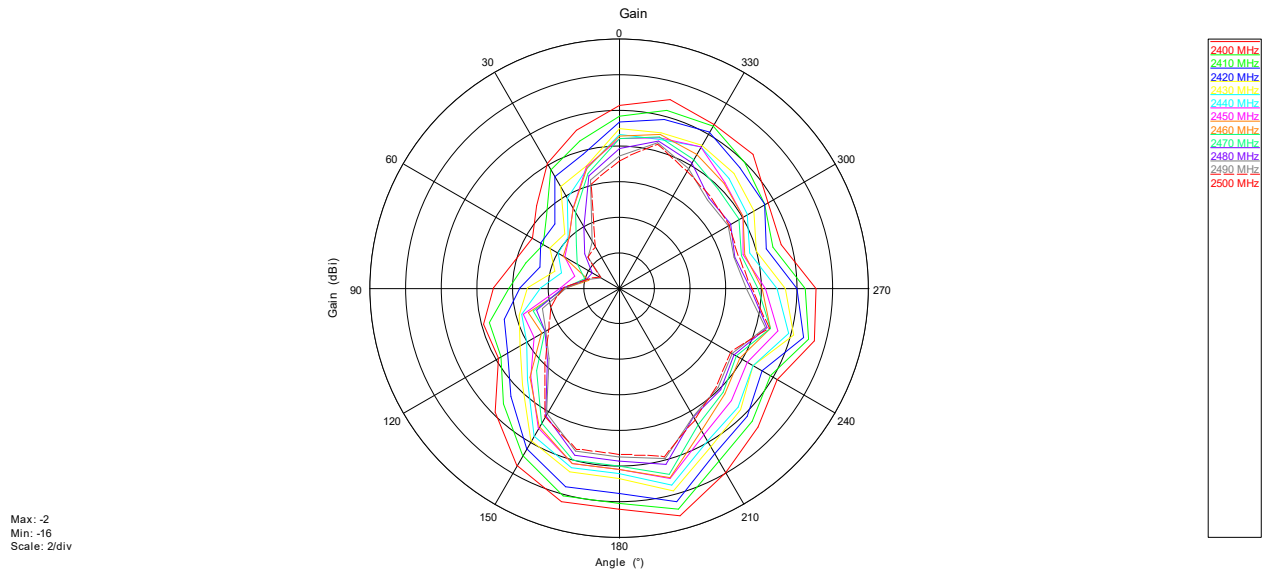

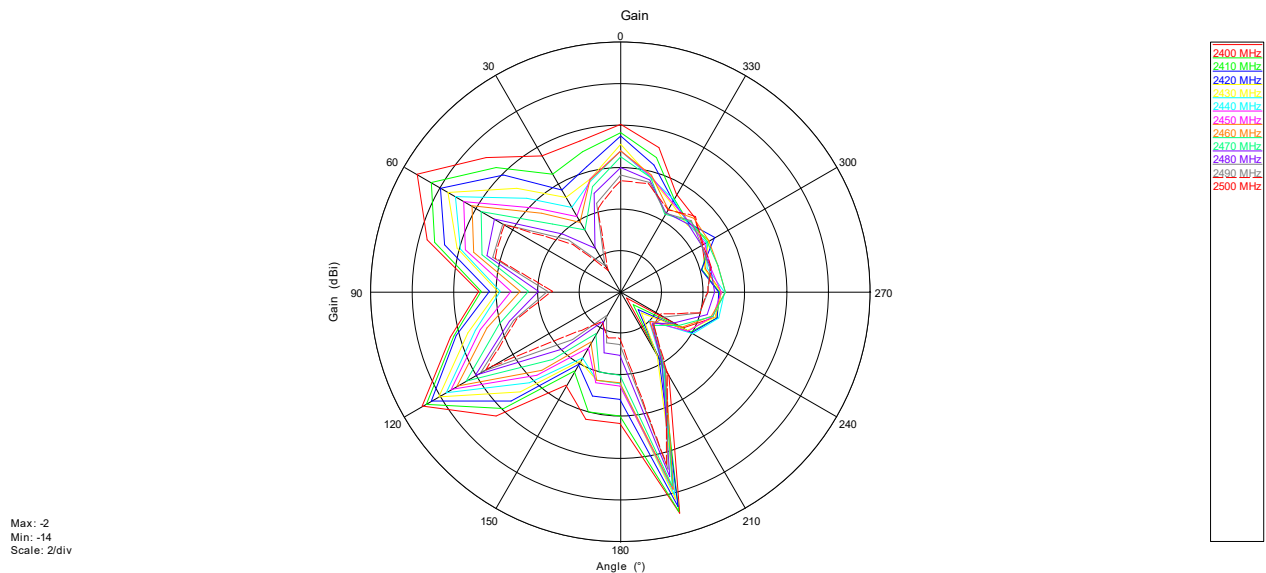

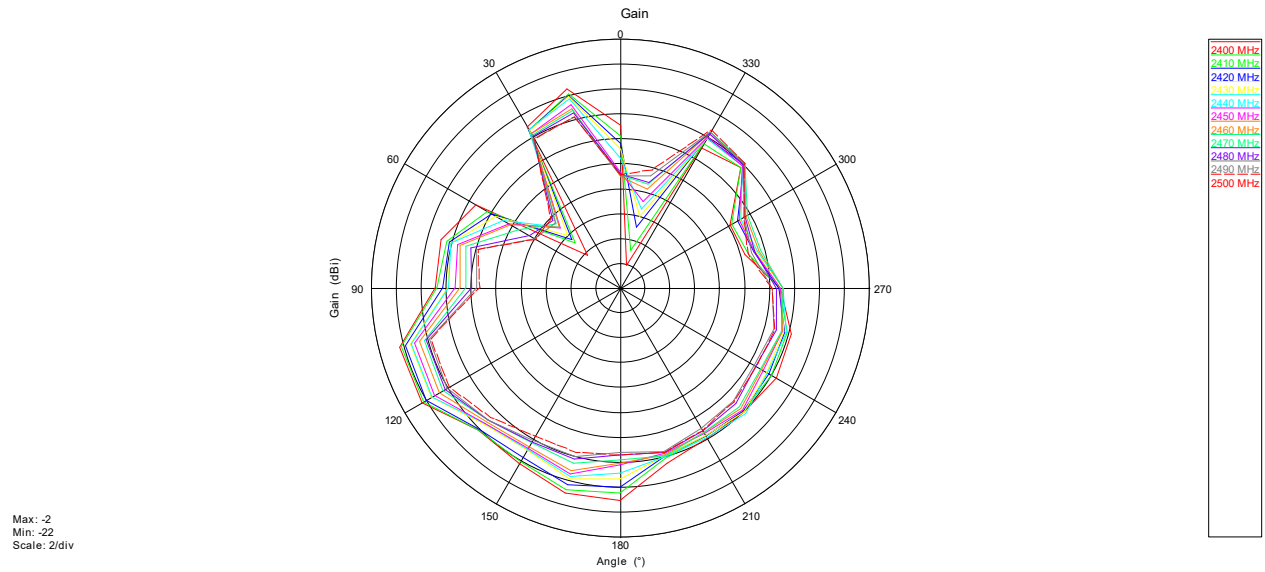
1. 2D Radiation Pattern



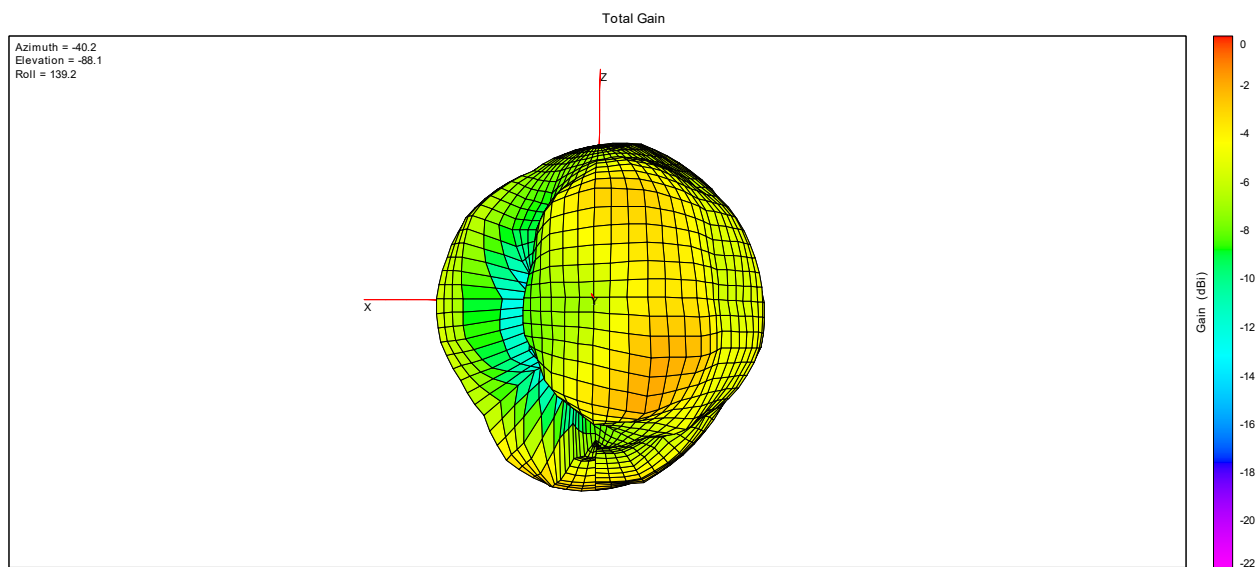

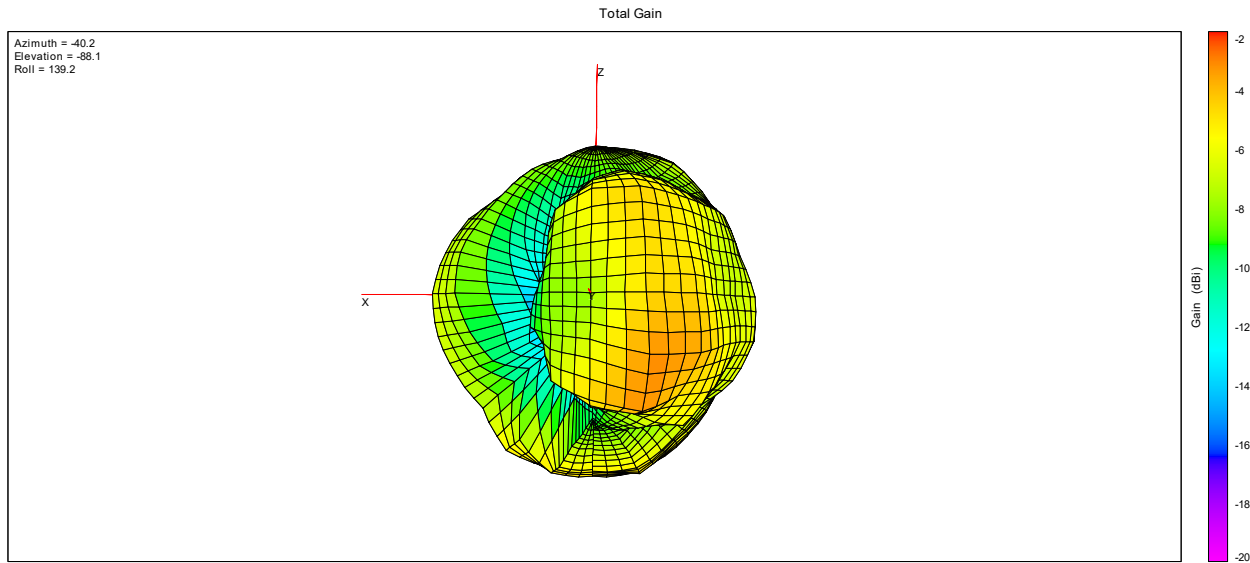
Phi=90°



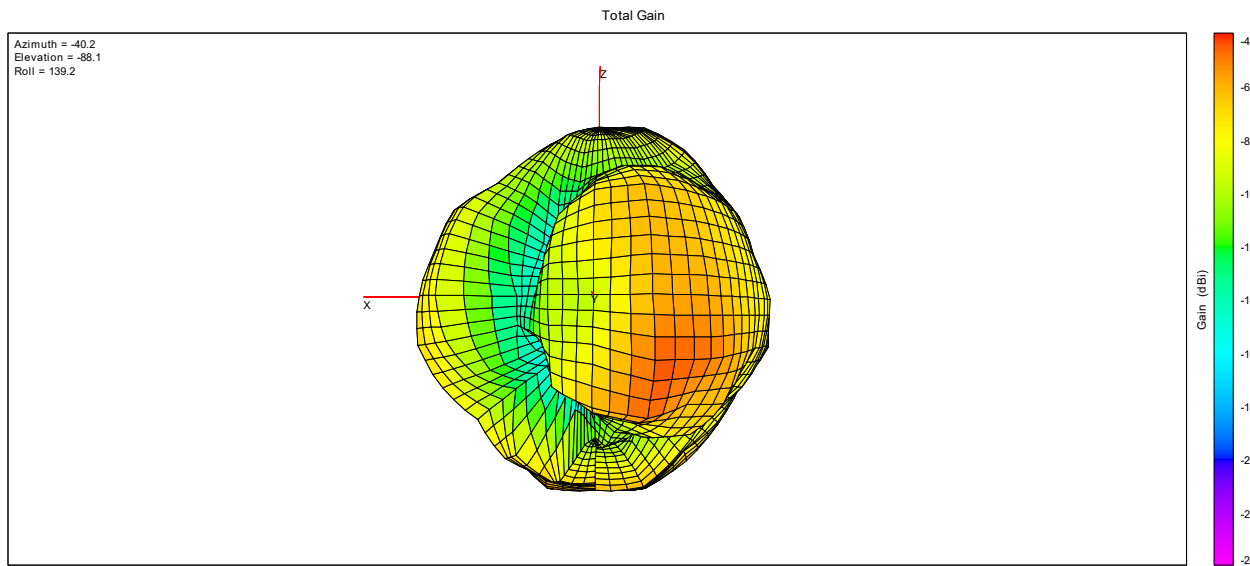
2. 3D Radiation Pattern

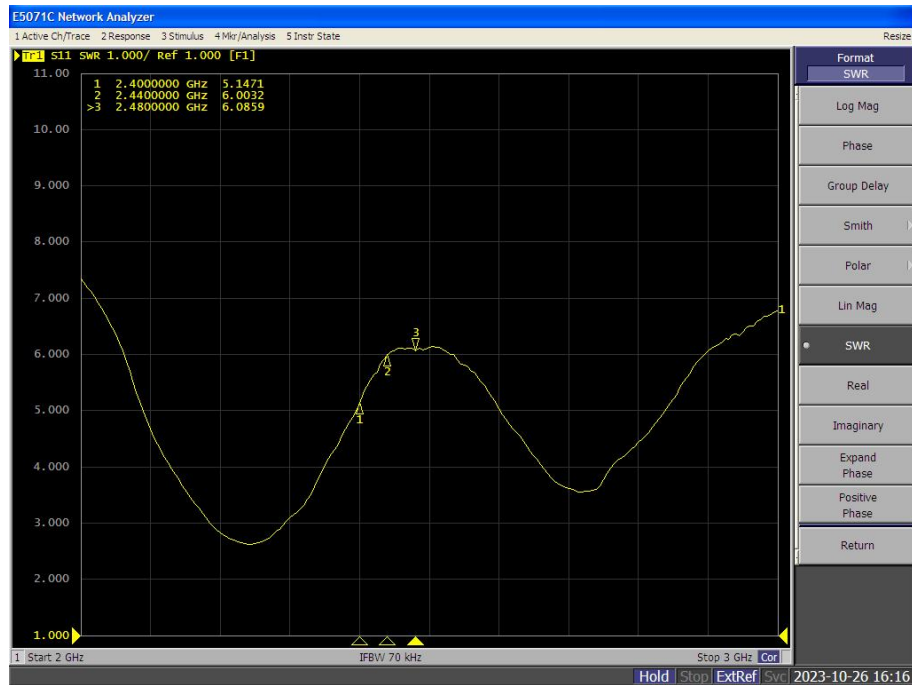
