- 1. MPR is permanently implemented for all channel BWs, modulations, frequency bands and RB sizes.
- 2. A-MPR was disabled for all SAR test samples for SAR testing purposes only.
- 3. We confirm the specific MPR targets and tolerances shown in the SAR Report.
- 4. LTE Rel.16 implementation is limited. The uplink supports LTE CA\_41C, CA\_5B, CA\_66B, CA\_66C and CA\_48C as described in filing. The uplink does not support other carrier aggregation nor enhanced SC-FDMA. Features such as CoMP, HetNet, Relay, SON, cross carrier scheduling, Uplink MIMO and M2M/D2 are also not supported. SVLTE is not supported as described in the operational description.
- 5.
