Measurement Record:

The minimum distance for the EUT is less than 5mm.

$$\frac{3*d}{\sqrt{f}} = 9.52 \text{ mW}.$$

Since maximum peak output power of the transmitter is 0.44 dBm ≈ 1.11 mW < 9.52 mW.

Hence the EUT is excluded from SAR evaluation according to FCC KDB Publication 447498 D01 General RF Exposure Guidance v06.
