Band7-5MHz-QPSK-21100-1RB#0-Range1:30~1000MHz

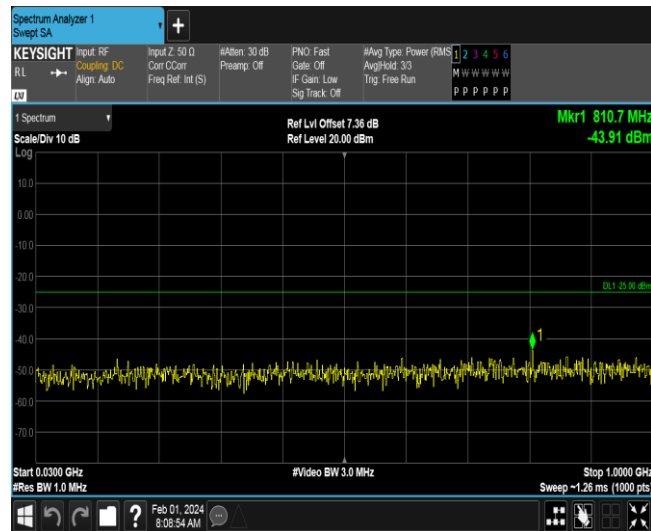

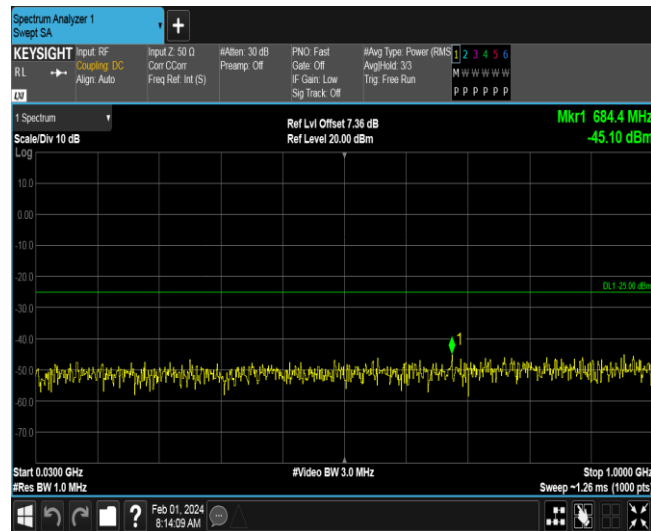


Band7-15MHz-16QAM-21100-1RB#0-Range2:1000~27000MHz

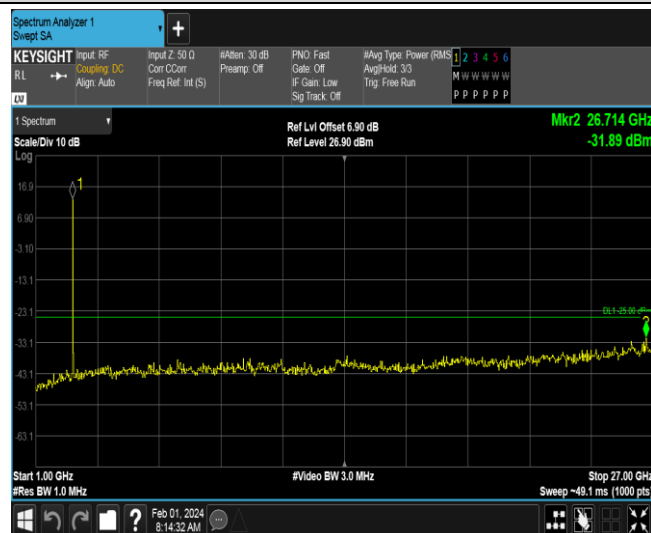

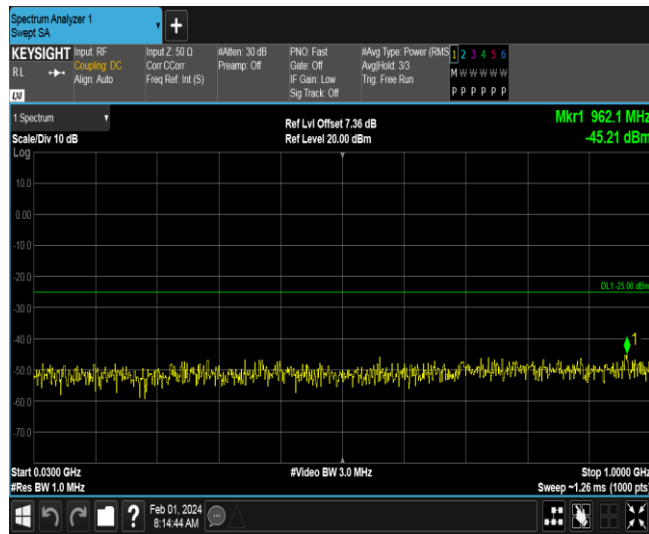

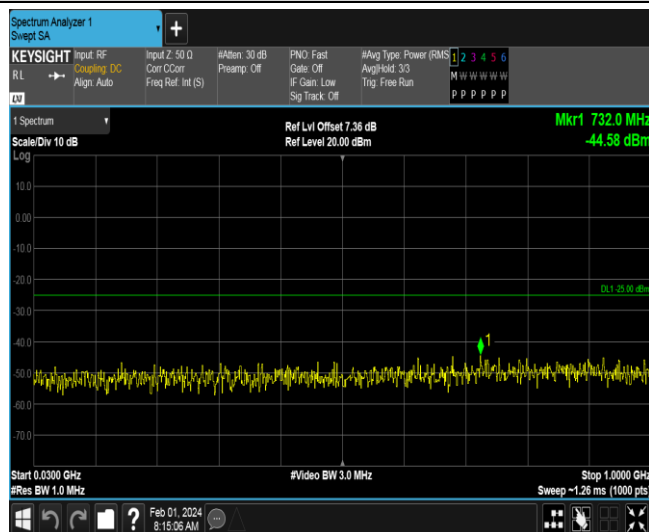

Band7-20MHz-QPSK-20850-1RB#0-Range2:1000~27000MHz

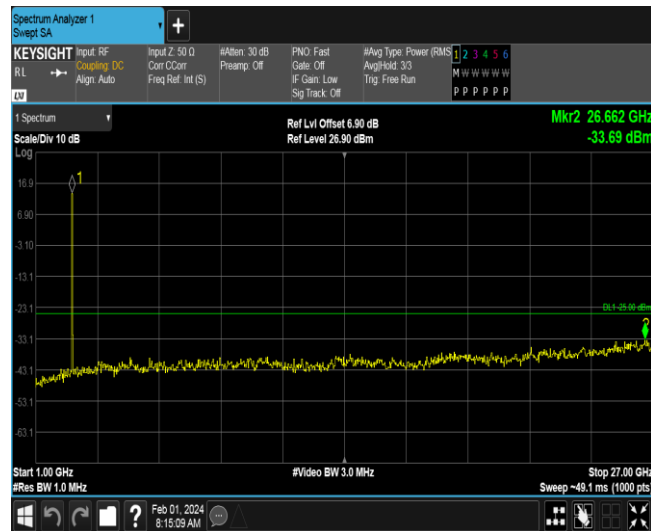


Band7-20MHz-QPSK-21100-1RB#0-Range1:30~1000MHz

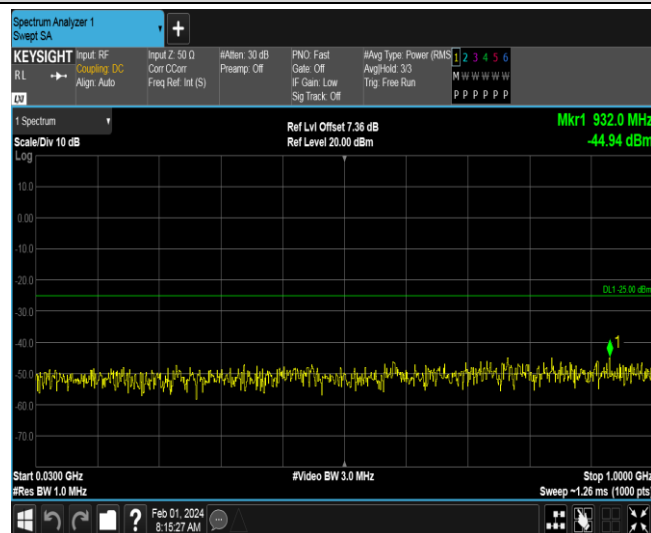
