These earbuds with 3-button & mic are compatible with all smartphones, Apple devices(iPod,iPhone,iPad), and samsung/Android mobile devices.

## Function view:

Turn on: Long press the power button until blue LED flashes

Turn off: Long press the power button until red LED flashes

To answer/end call, press the power button once to answer and press again to end the call

To reject call, hold and press the power button for 2 seconds

To play/pause music, press power button once

To raise volume, hold and long press the " Volume +" button

To lower volume, hold and long press the " Volume -" button

To skip to the next song, press " Volume +" button once

To go to the previous song, press " Volume -" button once

## PAIRING:

1, Go to "Bluetooth" settings on your bluetooth device(phone, tablet,etc)

2,Turn the bluetooth on of your devices.

3,Turn your headphones into pair mode by turning headphone on(hold and press the power button), until the led light flashes between red and blue, indicating you have successfully entered pairing mode.

4,Select" Monster Stream Mono " on the bluetooth list of your deivces.

5,You are now connected Trouble shooting tips: if the bluetooth pairing does not sync, turn off the bluetooth on your device as well as turn off the headphones, then turn on the device's bluetooth followed by the headphones and follow the instructions normally

## Charging :

To charge the bluetooth earbuds for the first time: Plug in the power cable and charge it for 1-2 hours The light will turn red when charging and turn blue when fully charged.
