

Method 2: Long touch the MF button of the headphones for 3s to turn on the headphones.

Method 2: Long touch the MF button of the headphones for 5s to turn off the headphones.
- Pairing to the BT device
Step 1: Open the upper cover of the charging compartment to remove the headphones, binaural automatic pairing.
Step 2: open the BT list of smart devices, search "Space Y3 Pro" and connect (single ear use is supported).

■ Left/right headphone operation

- Previous song: Long press left ear for 2 seconds
- Next song: Long press the right ear for 2 seconds
- Volume+: Click on the right ear
- Volume-: Click on the left ear
- Pause/Play: Double click any headphone function key

Phone Hands Free

■ Left/right headphone operation (in incoming call state)

- Answer: Double click any headphone function key
- Reject: Press and hold any headphone function key for 2 seconds to release
- Hanging up: Double click any headphone function key

Game mode/Music mode

■ Left/Right Earphone Operation

- Three clicks on the right earphone function key for 3 seconds to switch between game/music modes

Voice Assistant

■ Left/Right Earphone Operation

- Three clicks on the left earphone function key to wake up Siri in 3 seconds

Restore factory settings

After turning on the phone without pairing state, click the headset function key 4 times to clear the pairing information and then turn off the phone.
