4.4 TEST METHODOLOGY

All measurements contained in this report were conducted with ANSI C63.10-2013, American National Standard of Procedures for Compliance Testing of Unlicensed Wireless Devices.

The radiated testing was performed at an antenna-to-EUT distance of 3 meters. All radiated and conducted emissions measurement was performed at Dongguan Yaxu (AiT) Technology Limit.

EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

EUT Exercise

The EUT was operated in the normal operating mode and a continuous transmits mode for other tests.

According to its specifications, the EUT must comply with the requirements of the Section 15.203, 15.205, 15.207, 15.209, 15.247 under the FCC Rules Part 15 Subpart C and RSS-247 Issue 2, RSS-Gen Issue 5.

General Test Procedures

Conducted Emissions

The EUT is placed on the turntable, which is 0.8 m above ground plane. According to the requirements in Section 6.2.1 of ANSI C63.10-2013 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using Quasi-peak and average detector modes.

Radiated Emissions

The EUT is placed on a turn table, which is 0.8 m above ground plane. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the maximum emissions, exploratory radiated emission measurements were made according to the requirements in Section 6.3 of ANSI C63.10-2013.



4.5 Description of Test Modes

The EUT has been tested under operating condition.

Worst-case mode and channel used for 9 KHz-1000 MHz radiated emissions was determined to be TX(1Mbps-Low Channel).

This test was performed with EUT in X, Y, Z position and the worst case was found when EUT in X position.

In section 15.31(m), regards to the operating frequency range over 10 MHz, the Lowest frequency, the middle frequency, and the highest frequency of channel were selected to perform the test, and the selected channel see below:



- 2. Set the video bandwidth (VBW) \geq 3 x RBW.
- 3. Detector = Peak.
- 4. Trace mode = max hold.
- 5. Sweep = auto couple.
- 6. Allow the trace to stabilize.
- 7. Measure the maximum width of the emission that is constrained by the frequencies associated with the two outermost amplitude points (upper and lower) that are attenuated by 20 dB relative to the maximum level measured in the fundamental emission.





- --- The measurement distance is 3 meter.
- --- The EUT was set into operation.

Premeasurement:

- --- The turntable rotates from 0° to 315° using 45° steps.

- --- At each turntable position the analyzer sweeps with peak detection to find the maximum of all emissions

Also a plot with the graph of the premeasurement with marked maximum final measurements and the limit will be stored.



6.4 Conducted Emissions

6.9.1 Standard requirement:

According to §15.207 (a): For an intentional radiator which is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed 250 microvolts (The limit decreases linearly with the logarithm of the frequency in the range 0.15 MHz to 0.50 MHz). 


