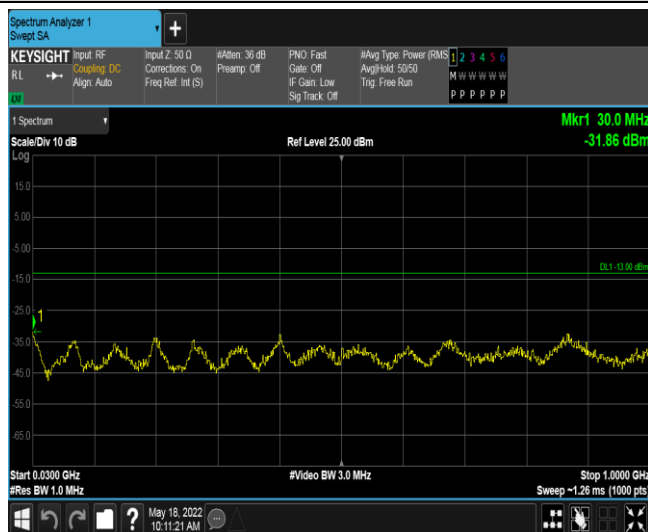

Band4-10MHz-16QAM-20175-1RB#0-Range3:2000~20000MHz

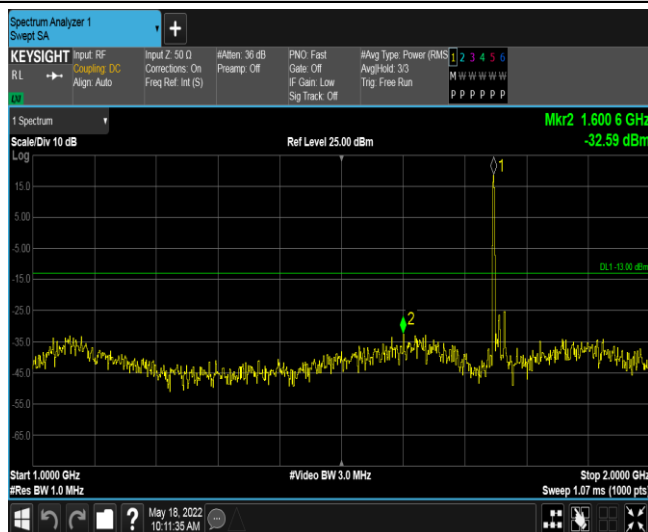


Band4-10MHz-16QAM-20350-1RB#0-Range1:30~1000MHz

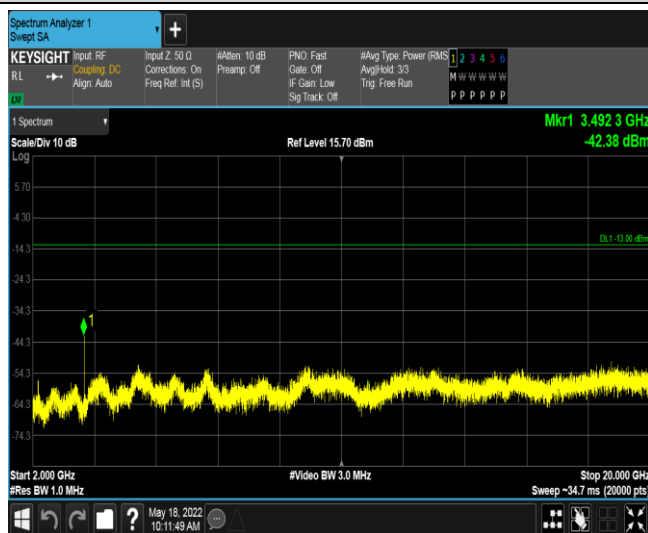
