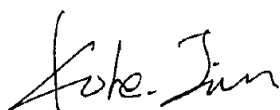

5 Technical Requirements Specification

5.1 RF Exposure Evaluation

5.1.1 Limit & Test Method

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances ≤ 50 mm are determined by:

$$\frac{[(\text{max. power of channel, including tune-up tolerance, mW})/(\text{min. test separation distance, mm})]}{\sqrt{f(\text{GHz})}} \leq 3.0$$
 for 1-g SAR and ≤ 7.5 for 10-g extremity SAR, where

- $f(\text{GHz})$ is the RF channel transmit frequency in GHz
- Power and distance are rounded to the nearest mW and mm before calculation¹⁷
- The result is rounded to one decimal place for comparison

The test exclusions are applicable only when the minimum test separation distance is ≤ 50 mm and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is < 5 mm, a distance of 5 mm is applied to determine SAR test exclusion

5.1.2 Conclusion

The Max. power (including tune-up tolerance) is 0.48 dBm on the lowest channel 2.402 GHz (*)
0.48 dBm logarithmic terms convert to numeric result is nearly 1.12 mW
According to the formula, calculate the test exclusion thresholds:

$$\frac{[(\text{max. power of channel, including tune-up tolerance, mW})/(\text{min. test separation distance, mm})]}{\sqrt{f(\text{GHz})}}$$

$$\text{General RF Exposure} = (1.12 \text{ mW} / 5 \text{ mm}) \times \sqrt{2.402 \text{ GHz}} = 0.35 \quad (1)$$

SAR requirement:

$$S = 3.0 \quad (2)$$

$$(1) < (2)$$

So the SAR report is not required.
