


◆ Safety Warning


◆ Installation Procedure

Warning: Please make sure the power cord of the Interactive Intelligent Panel is disconnected before installation.

Step 1: Tear off the patch. Use a Phillips screwdriver to loosen two screws and remove the cover.



Step 2: Insert the module upward into the platform of Interactive Intelligent Panel in the direction of the arrow.



Step 3: Complete the connection.

Note: This Wi–Fi module only works for the Interactive Intelligent Panel by plugging it into the above slot.

♦ Software Function

- ① After installation, open the Interactive Flat Panel and the wireless module will run automatically.
- 2 Click on Settings, on the menu.
- $\ensuremath{\mathfrak{J}}$ Click on "Wireless Network" and you can turn the wireless network on / off.



4 Click on the "icon to enter the wireless hotspot.
