





### **Duty Cycle Correction During 100msec**

Each function key sends a different series of characters, but each packet period (18.6msec) never exceeds a series of 34 long or short (0.3msec) pules. Assuming any combination of short and long pules may be obtained due to encoding the worse case transmit duty cycle would be considered 34x0.3msec per 18.6msec=54.8% duty cycle. Figure A through C show the characteristics of the pulse train for one of these function.




