Important Safety Instructions

The applied nameplate is located at the bottom of the Baby Unit's base. When using your equipment, basic safety precautions should always be followed to reduce the risk of fire, electric shock and injury, including the following:

- Follow all warnings and instructions marked on the product.
- Adult setup is required.
- CAUTION:** Do not install the Baby Unit at a height above 2 meters.
- This product is not a substitute for adult supervision of the infant. Supervising the infant is the parent's or caregiver's responsibility. This product could cease operating, and therefore you should not assume it will continue working properly for any given period of time. Further, this is not a medical device and should not be used as such. This product is intended to assist you in supervising your baby.
- Do not use this product near water. For example, do not use it next to a bath tub, wash bowl, kitchen sink, laundry tub or swimming pool, or in a wet basement or shower.
- CAUTION:** Use only the battery provided. There may be a risk of explosion if a wrong type of battery is used for the Parent Viewer. The battery cannot be subjected to high or low extreme temperature and low air pressure at high altitude during use, storage or transportation. Disposal of battery into fire or a hot oven, or mechanically crushing or cutting or the battery can result in an explosion. 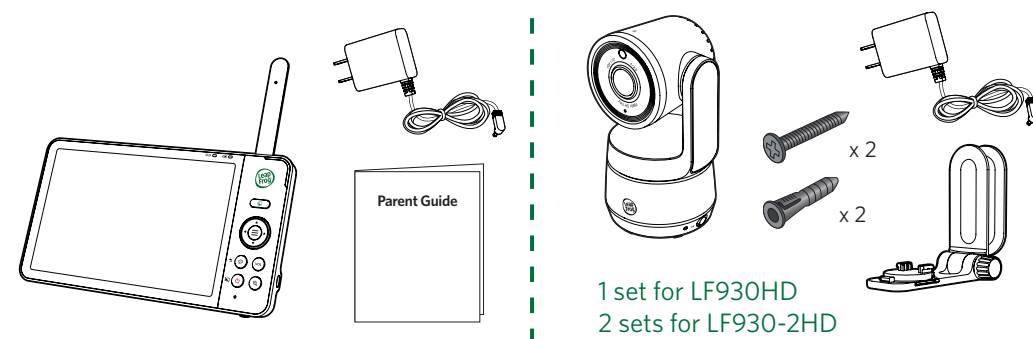

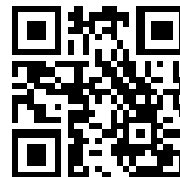

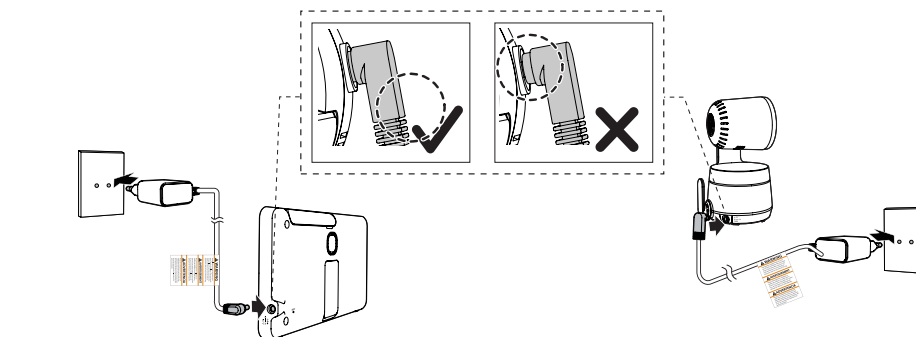

Connect, Charge, and Power On the Baby Monitor

1. Connect the Baby Monitor



2. Charge the Parent Viewer Battery

Notes:

- Before using the baby monitor for the first time, charge the Parent Viewer battery for 12 hours. When the Parent Viewer battery is fully charged, the battery icon becomes solid.
- The standby time varies depending on your actual usage time and the age of the battery.

The battery icon on the screen indicates the battery status:

Battery Indicators	Battery Status	Action
The screen displays . The light flashes.	The battery is low in power and may only be used for a short time.	Charge without interruption (about 30 minutes).
The battery icon becomes solid .	The battery is fully charged.	To keep the battery charged, connect it to AC power when not in use.

3. Power On or Off the Baby Monitor

- Slide the On/Off switch to **ON** to power on your Baby Unit.
- Press and hold until the welcome screen appears.

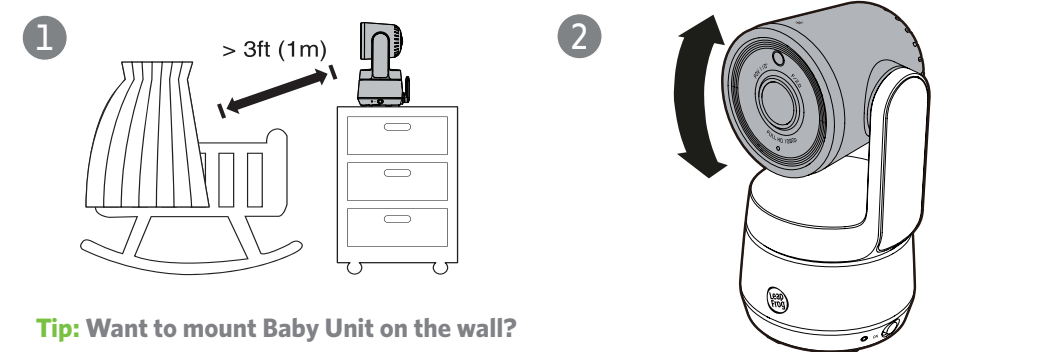

4. Status Check

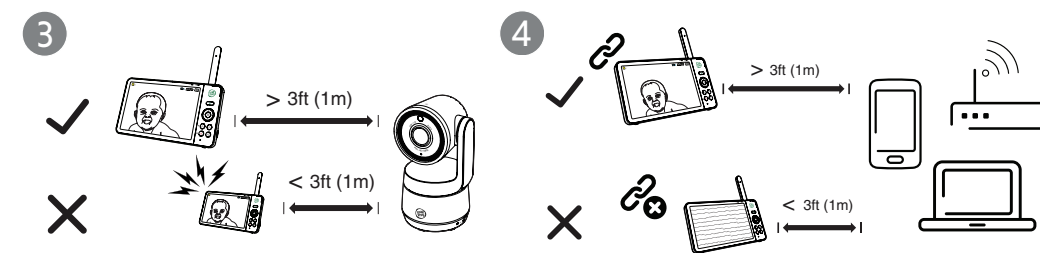
Once your Baby Unit and Parent Viewer are powered on and connected, your Parent Viewer displays video from the Baby Unit, and the LINK LED light turns on.

Note:

To avoid interference from other electronic devices, place your baby monitor at least 3 feet (1 meter) away from devices such as wireless routers, microwaves, cell phones and computers.

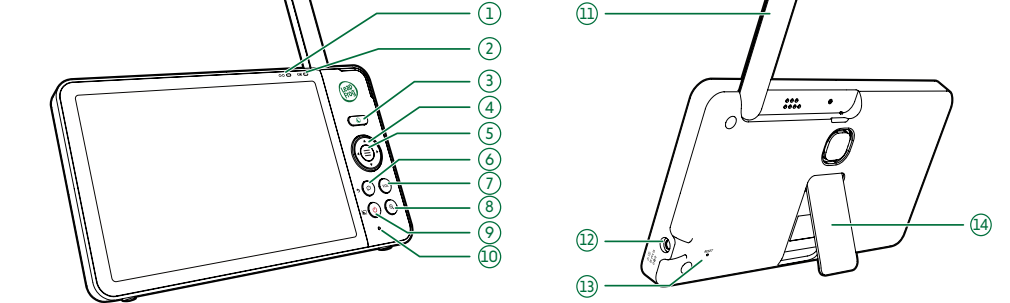
Caution:

The default volume of your Parent Viewer is level 3, and the maximum volume is level 5. If you experience a screeching noise from your baby monitor while positioning:

- Make sure your Baby Unit and Parent Viewer are more than 3 feet (1 meter) apart, **OR**
- Lower the volume of your Parent Viewer.

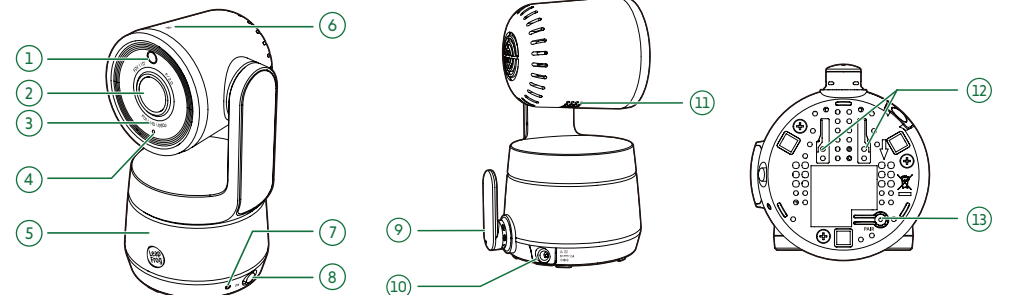

Three Ways to Connect Your Baby Monitor

Direct mode

The Parent Viewer and the Baby Unit are pre-paired and can connect to each other directly in **Direct mode** by default, which allows you to stream live video right out of the box.

Wi-Fi Router mode

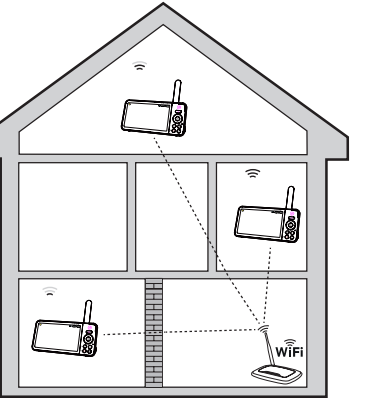
Router mode uses your home Wi-Fi network to connect your baby monitor system. It enhances your local access by extending connection range.

With the LeapFrog mobile app, your Wi-Fi router (not included) also provides Internet connectivity to your baby monitor system, allowing you to control your Baby Unit wherever you are.

Auto mode

The Parent Viewer will automatically select the most reliable connection mode (Direct or Wi-Fi) when connecting to the Baby Unit(s). Mobile app access will not be interrupted in Auto mode.

Test the Location



If you plan to install your Baby Unit to a designated location, and will use your home Wi-Fi network to connect your video monitor, test whether your selected monitoring areas have good Wi-Fi signal strength.

Check the Parent Viewer's Wi-Fi signal strength by going to:

> **Configure Wifi** > **Connection Status.**

Adjust the direction and distance between your Baby Unit, Parent Viewer, and Wi-Fi router until you have identified a suitable location with good connection.

Protect Your Privacy and Online Security

Activate Parking Mode:

- Press to enter the main menu.
- Go to **Baby Unit Settings.**
- Press to **Parking Mode**, press to toggle the switch on.
- To deactivate Parking Mode and resume normal operation, press on the Parent Unit.
