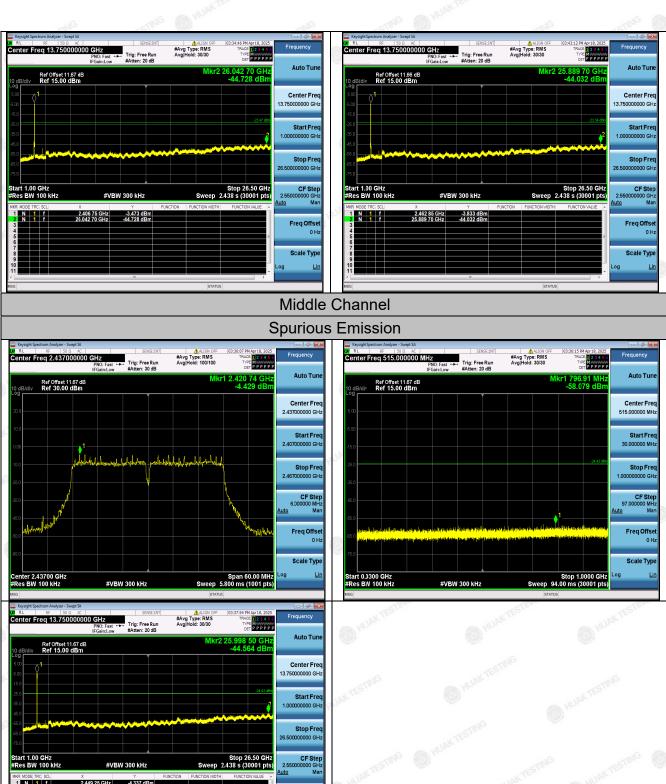
## 802.11n (HT20) Modulation
