注意事项

1.使用本产品时，请使用输出电压为5V=2A、9V=2A或带QC2.0/3.0快速充电功能的有品质保证的适配器
2.手机背面充电接触面不能有金属物质如铁片指环金属保护壳等。
3.手机进行充电时，如偶有发现断续充电或发热严重的情况。很可能是手机接收线圈与无线充线圈没有完全对准，手机保护套内部有金属异物，请尝试冷却手机拿掉保护壳再进行正确位置对位。
4.本产品有过流保护功能，如使用不当产品会关闭或减小输出功率，降低充电速度。为确保安全请检查设备是否有异常或其它使用不当。

5、使用环境温度保持在0-45℃，勿将产品置于水中、火中温度过高(>45℃)过低(<-20℃)中。勿给儿童接触、玩耍。
6.请使用干燥软布清洁表面，清洁时请断开电源。不要用化学品、肥皂或者洗涤剂清洗
