

## **5. TEST RESULTS**

### **5.1. Evaluation Results (Evaluation)**

#### **5.1.1. Antenna Requirement**

Test Requirement:

Refer to 47 CFR Part 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section.

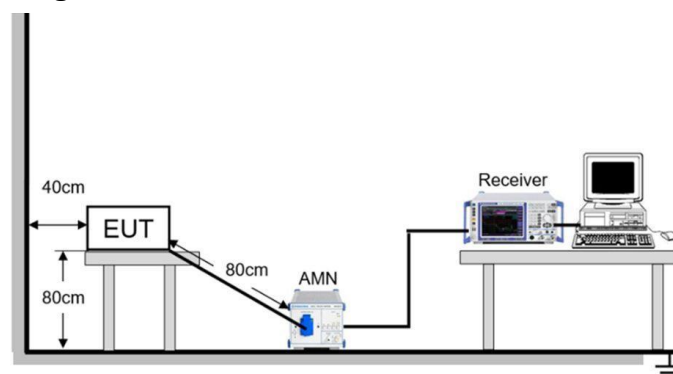

All other surfaces of EUT were at least 80 cm from any other grounded conducting surface.</li> <li>3. The EUT and simulators are connected to the main power through a line impedances stabilization network (LISN). 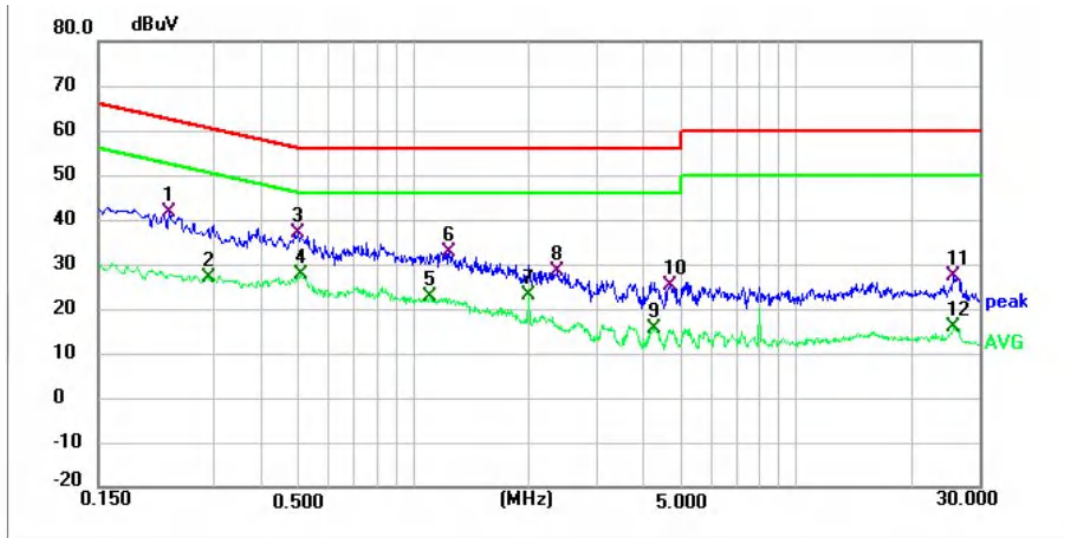

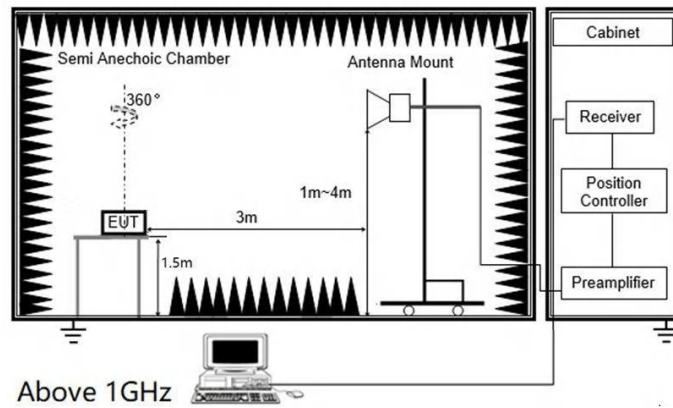

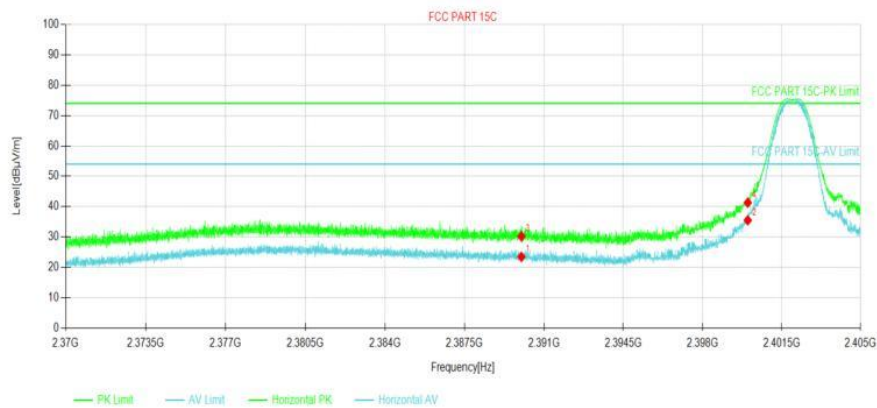

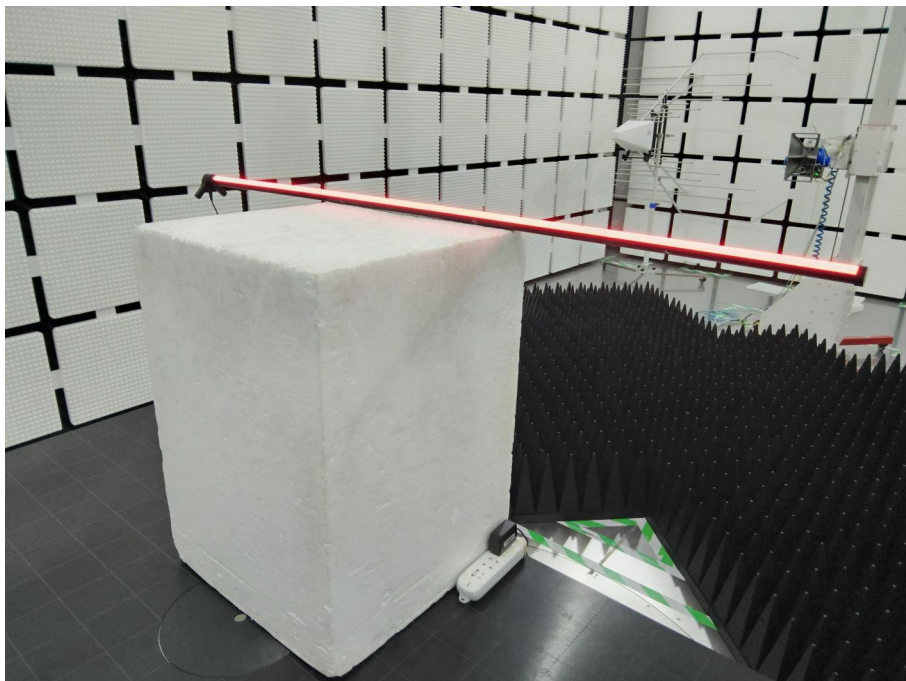

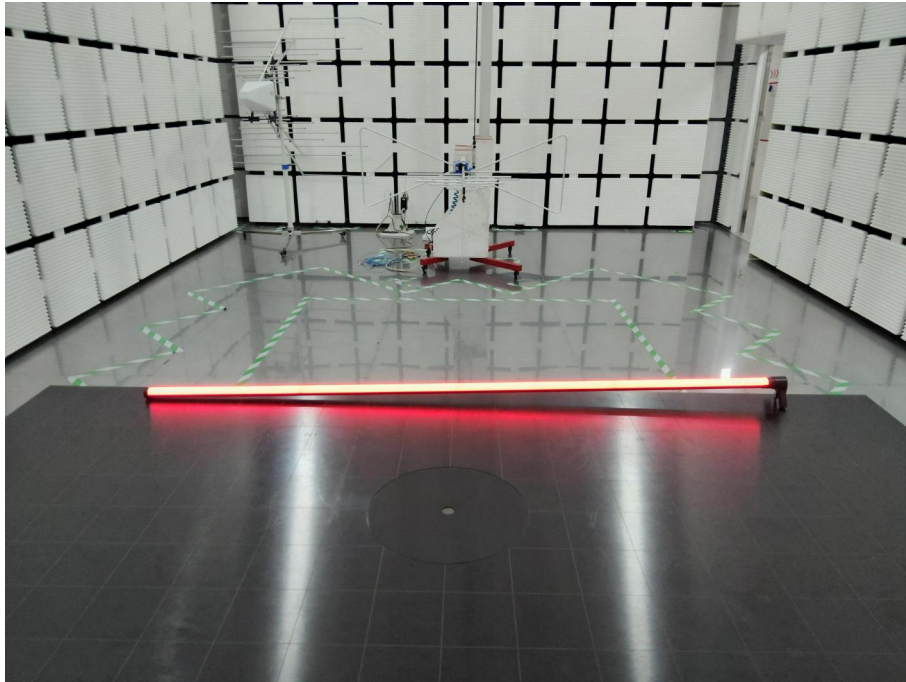

Radiated Spurious Emission (Above 1GHz)



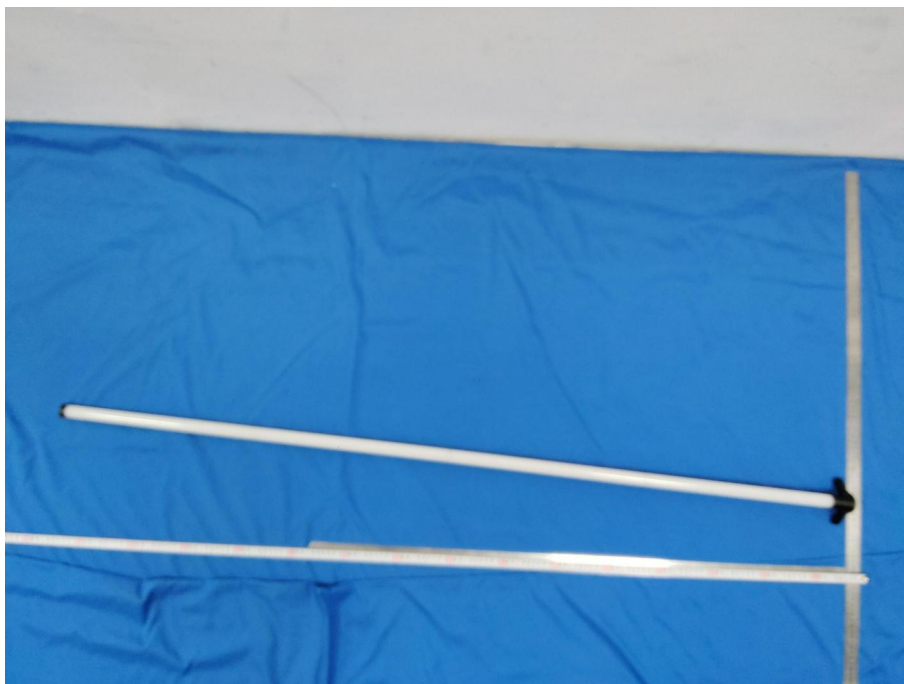
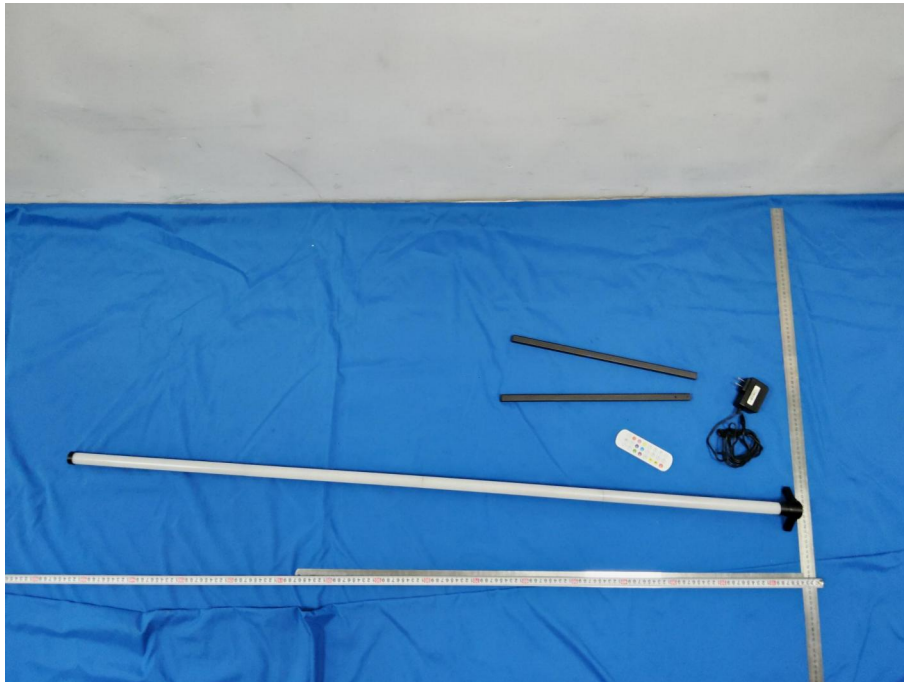
Radiated Spurious Emission (below 1GHz)



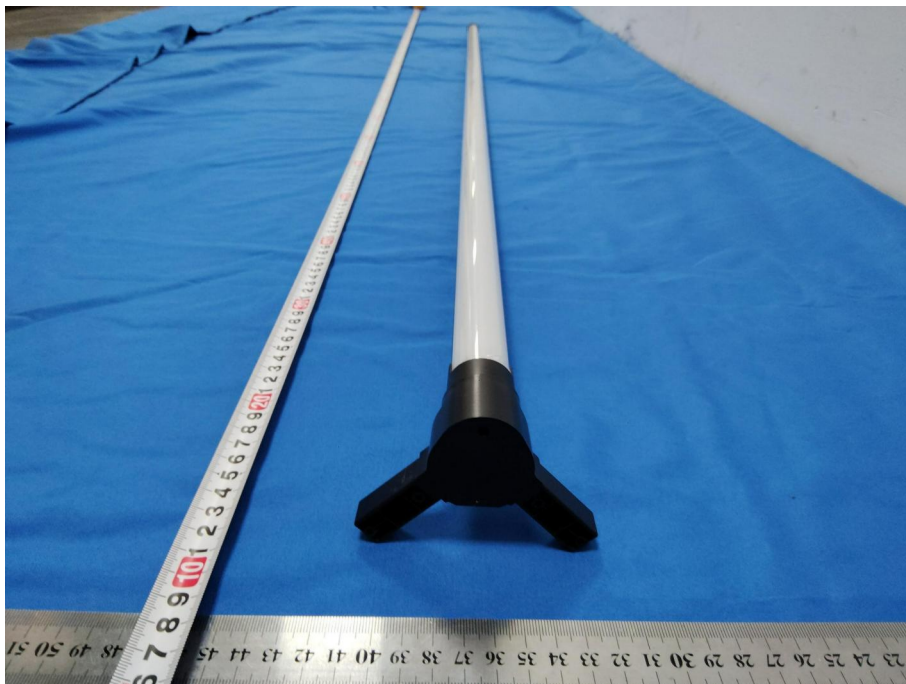
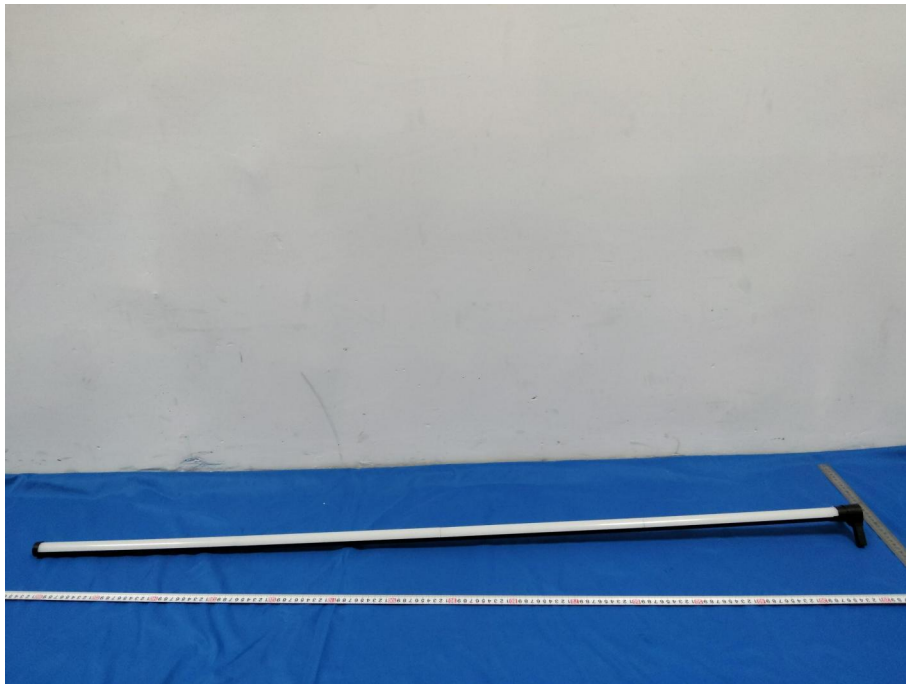
