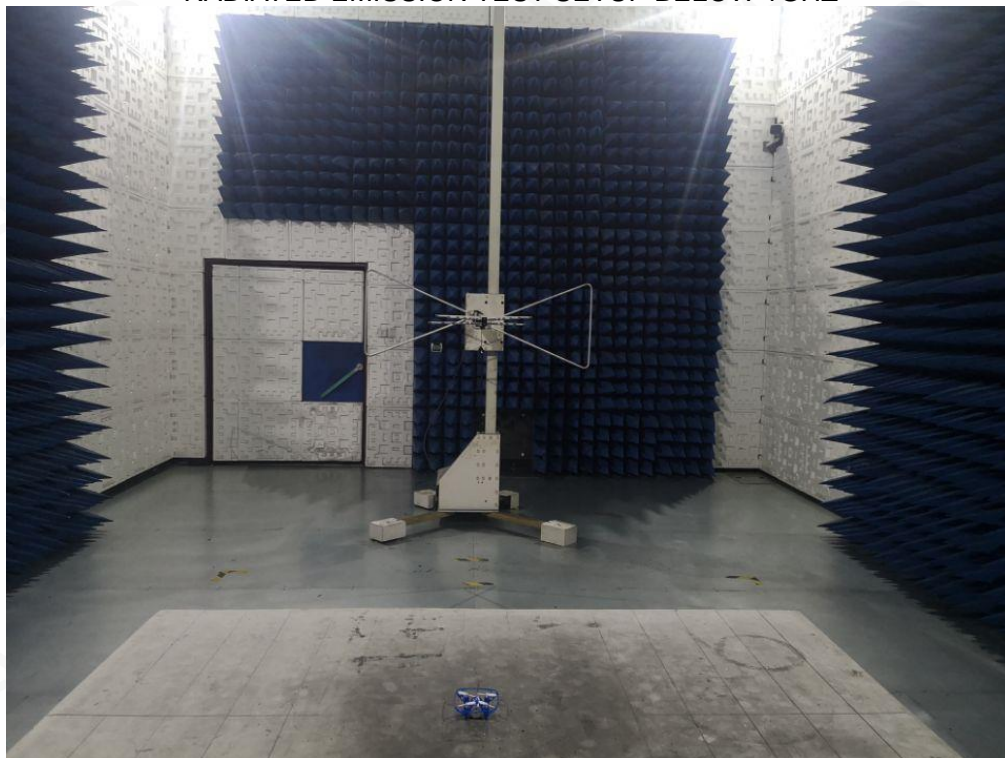

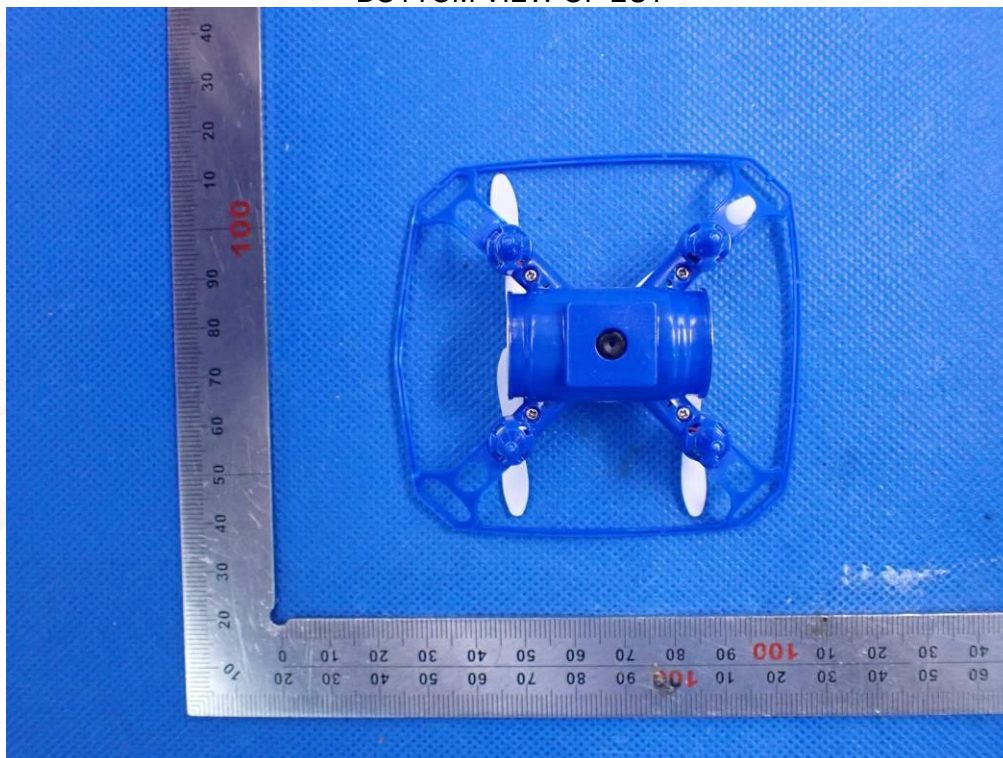

BOTTOM VIEW OF EUT

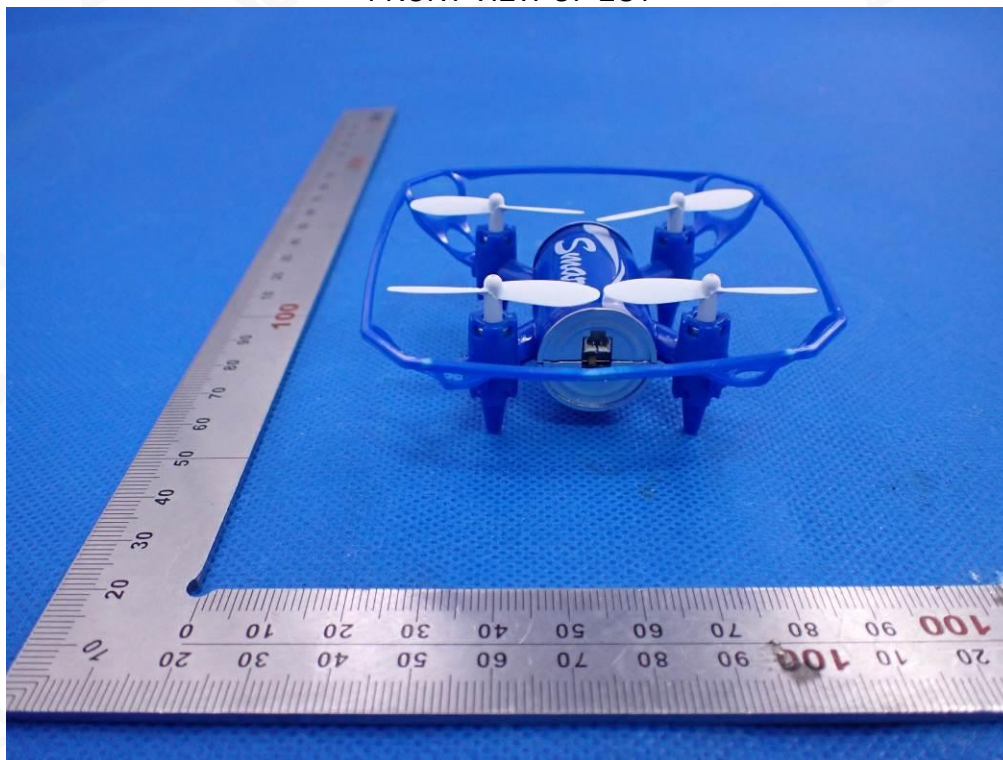

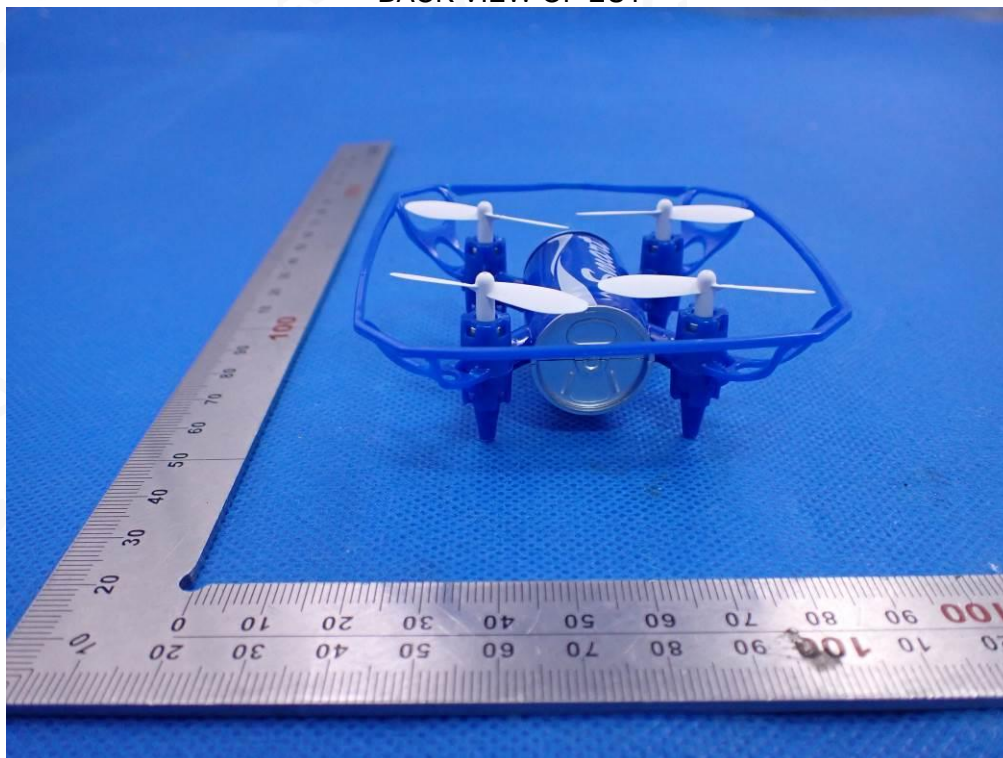

BACK VIEW OF EUT

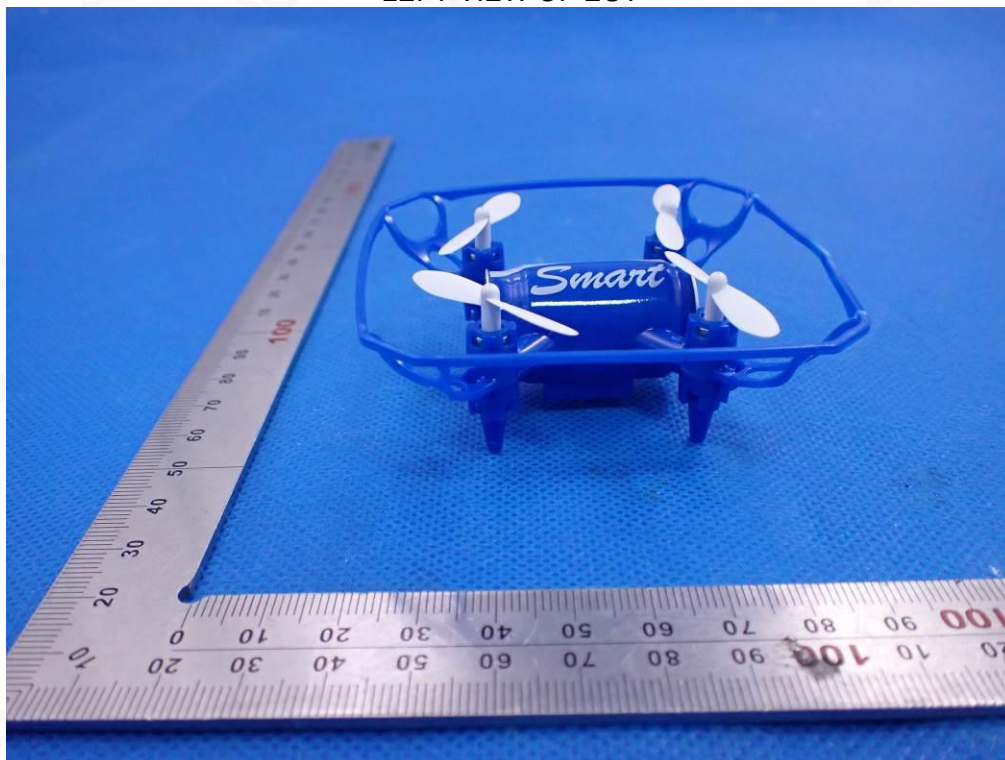

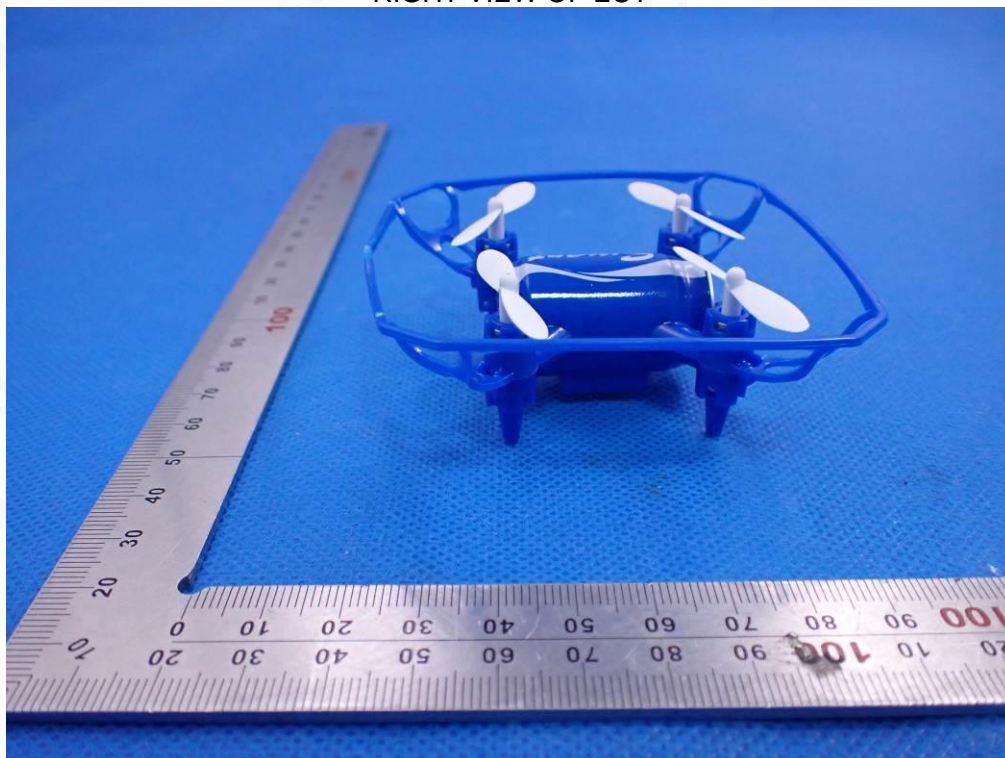

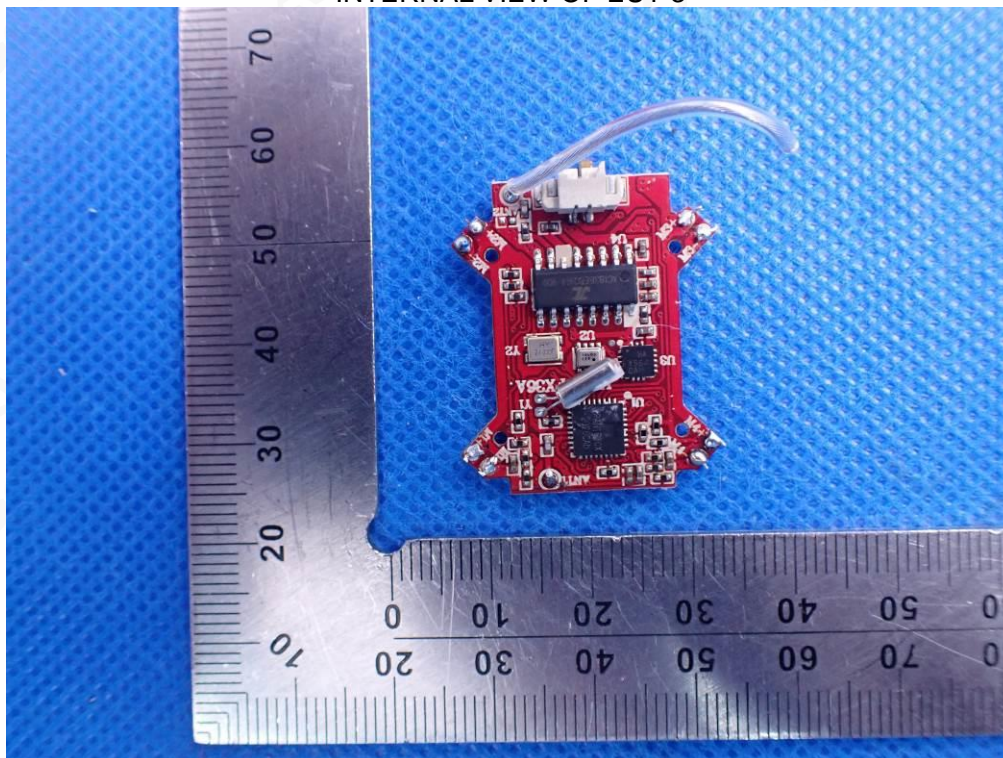

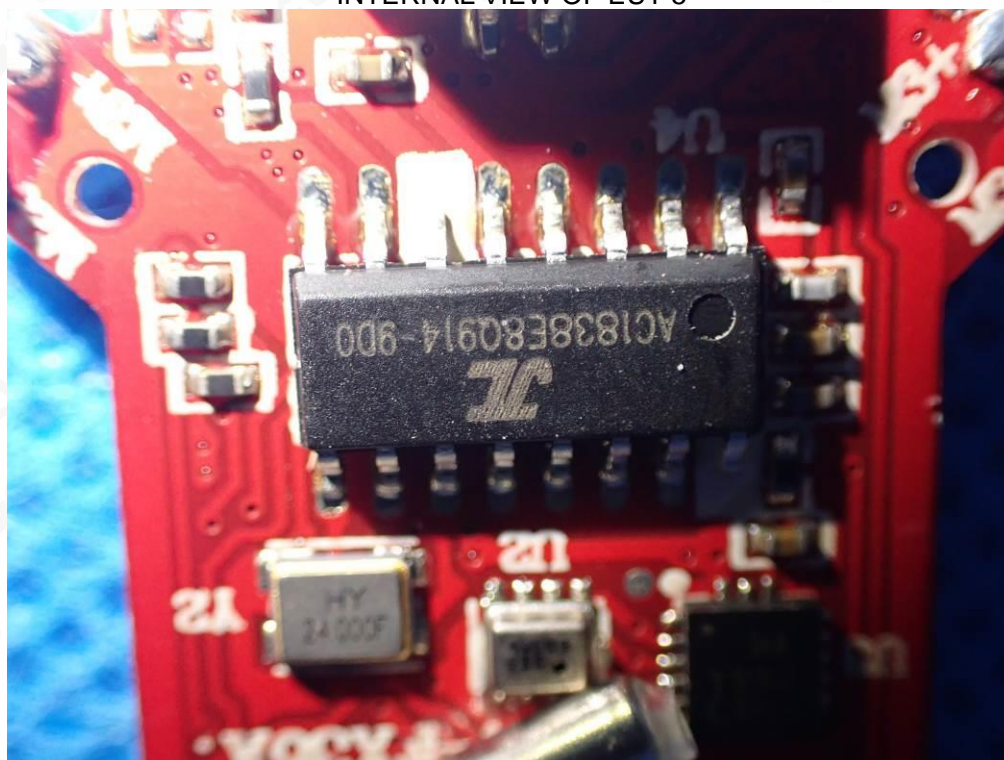
