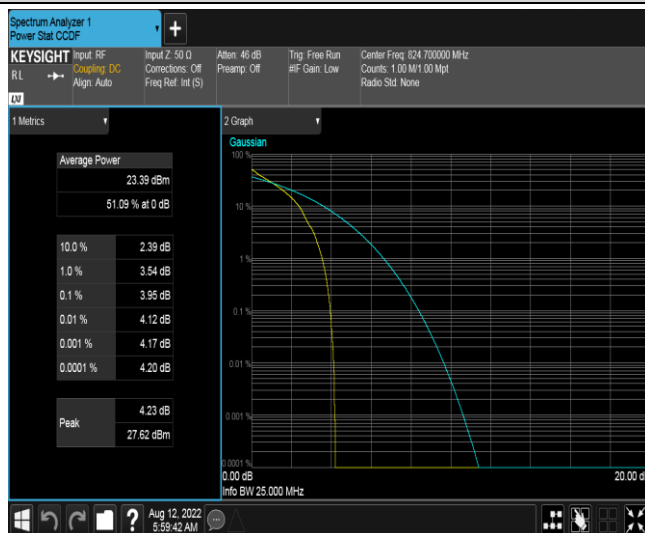

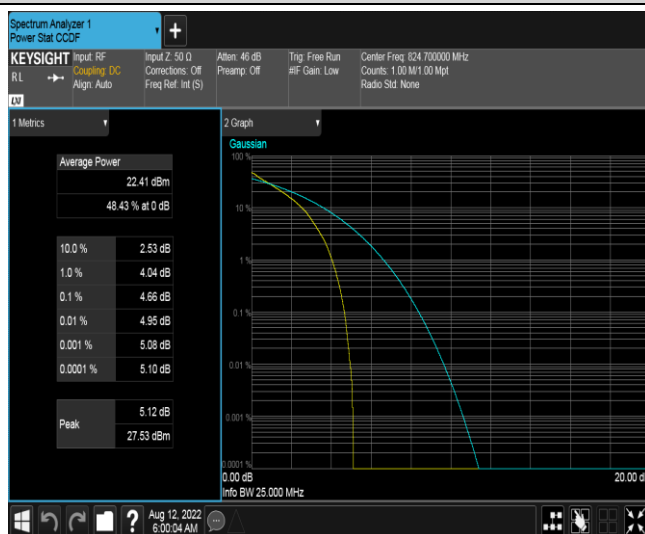

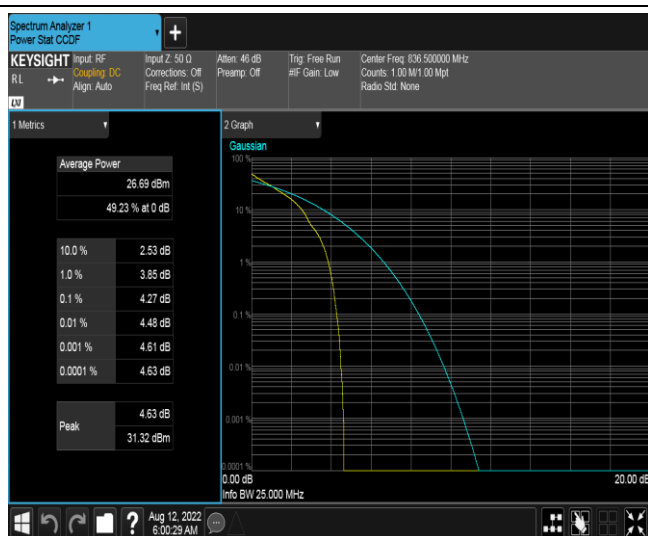


Band26-1.4MHz-QPSK-26797-6RB#0

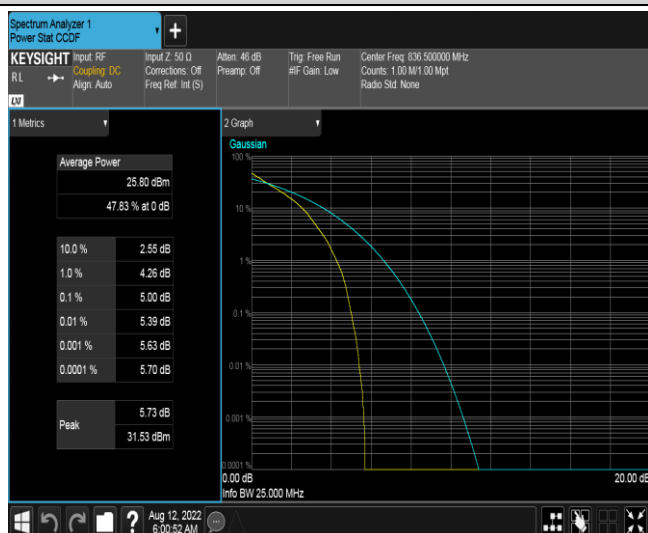
