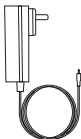

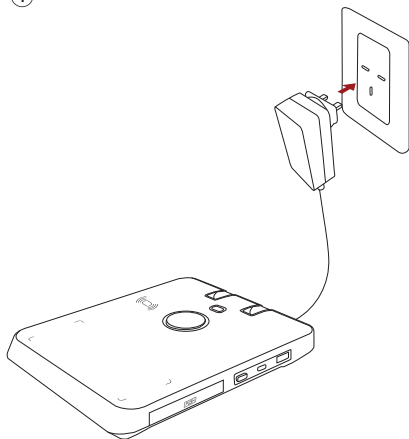

Working Conditions	LED Indicator
Power on	The red and white indicators alternately flash for about 2 seconds, then the red light is off, and the white light is on.
Charge devices	The white light flashes once a second.
Overheat protection	The red light flashes every 0.5 seconds.
Foreign object debris	The red light is always on.
Overcurrent short circuit protection	The red light flashes every 2 seconds.
Overvoltage /Undervoltage protection	The white light flashes once a second.

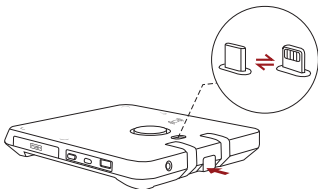

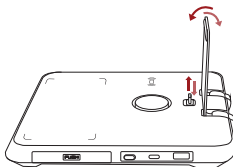


- ② Click the button to switch the Type-C & Lightning connectors.

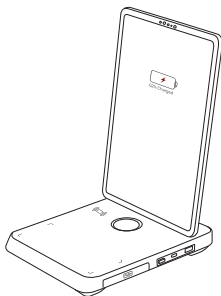
Notice: Connectors can only be switchable when the supporting stand is folded.



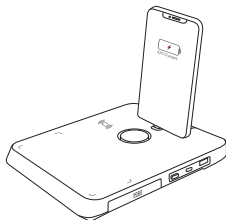
