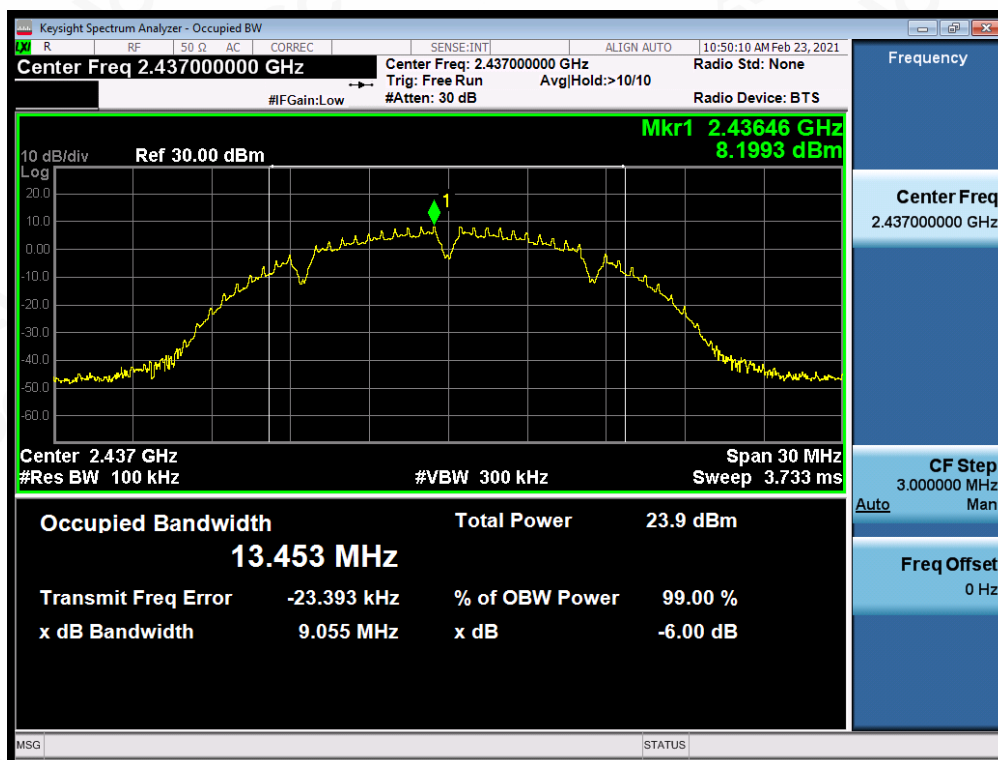

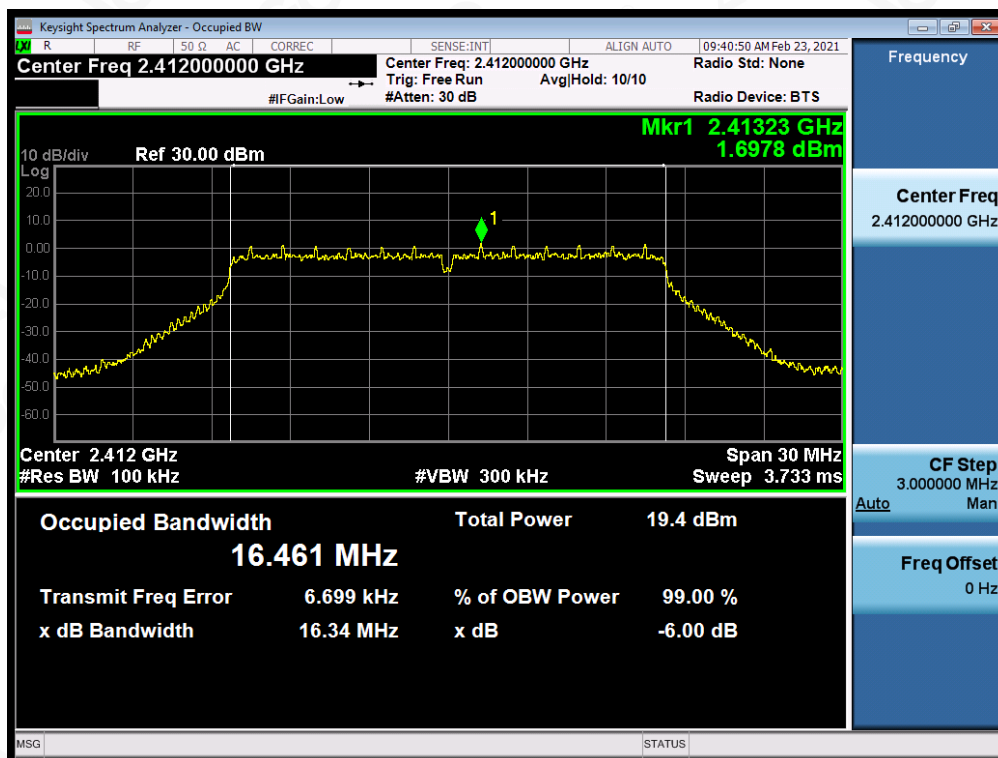


### TEST PLOT OF BANDWIDTH FOR HIGH CHANNEL

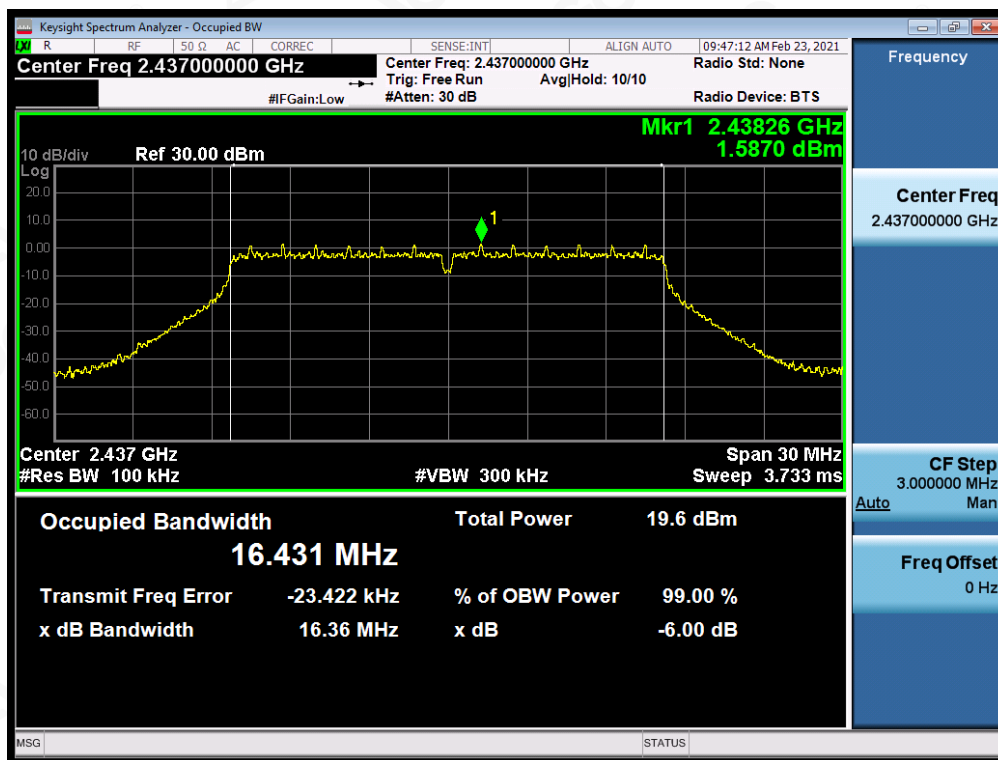

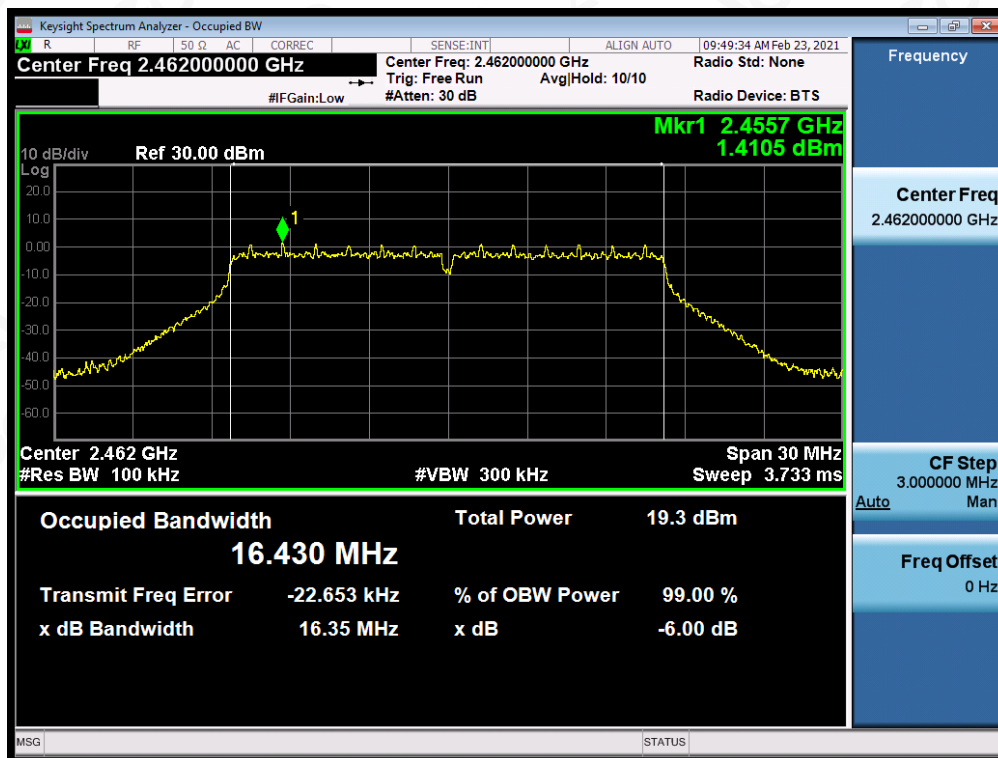




### TEST PLOT OF BANDWIDTH FOR MIDDLE CHANNEL



### TEST PLOT OF BANDWIDTH FOR HIGH CHANNEL



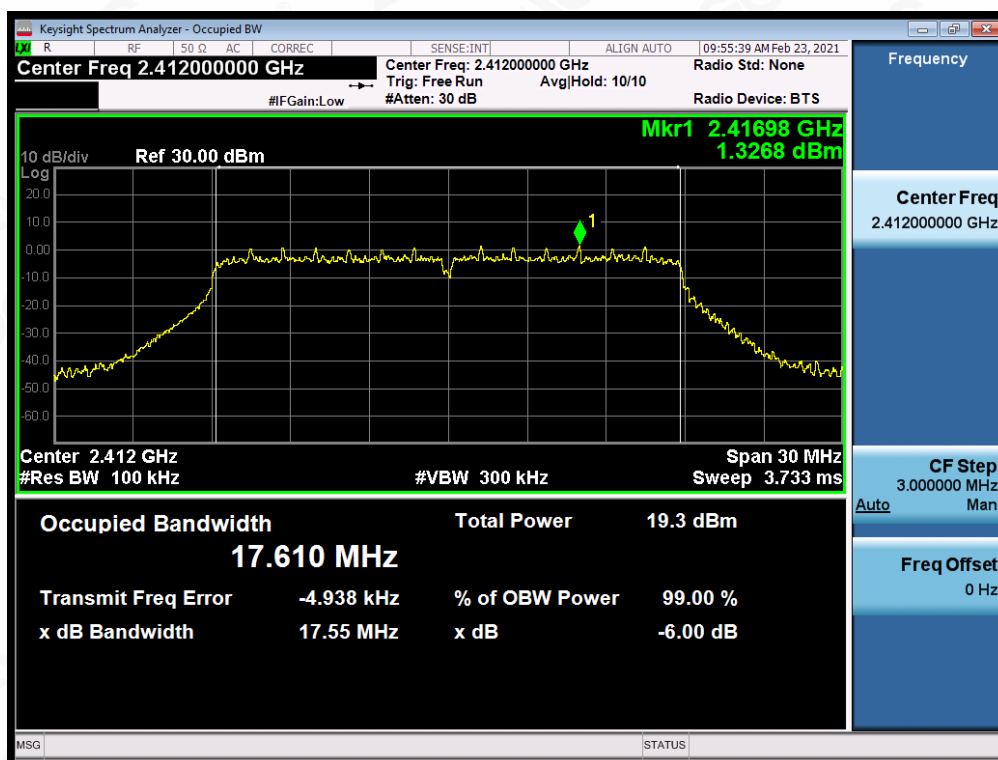

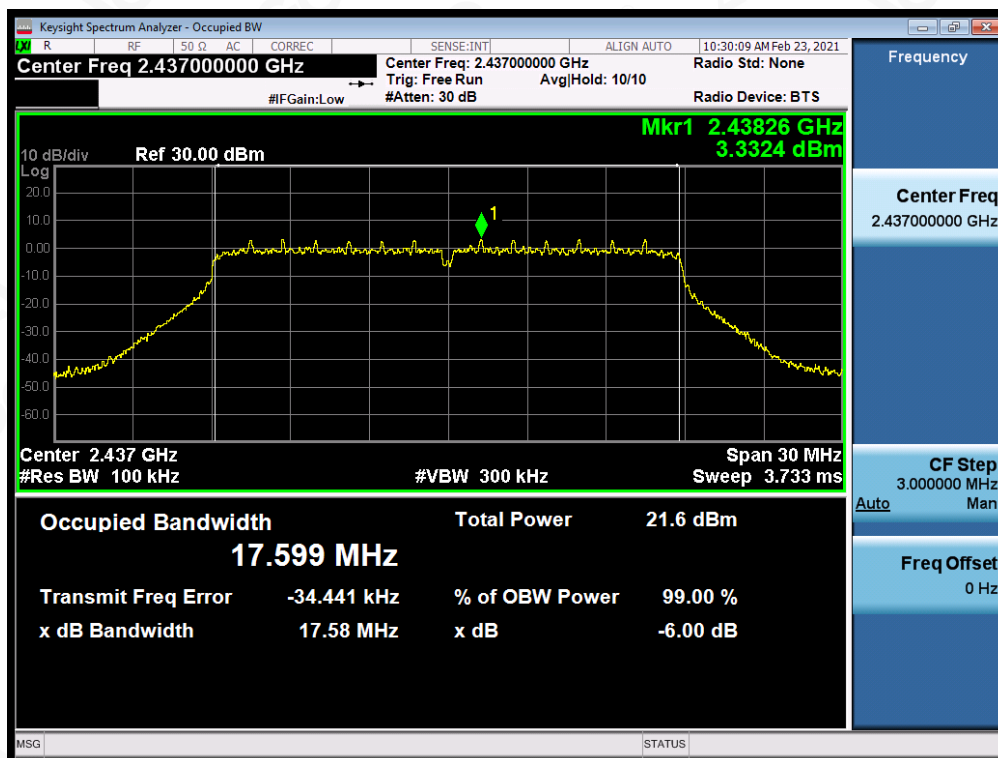

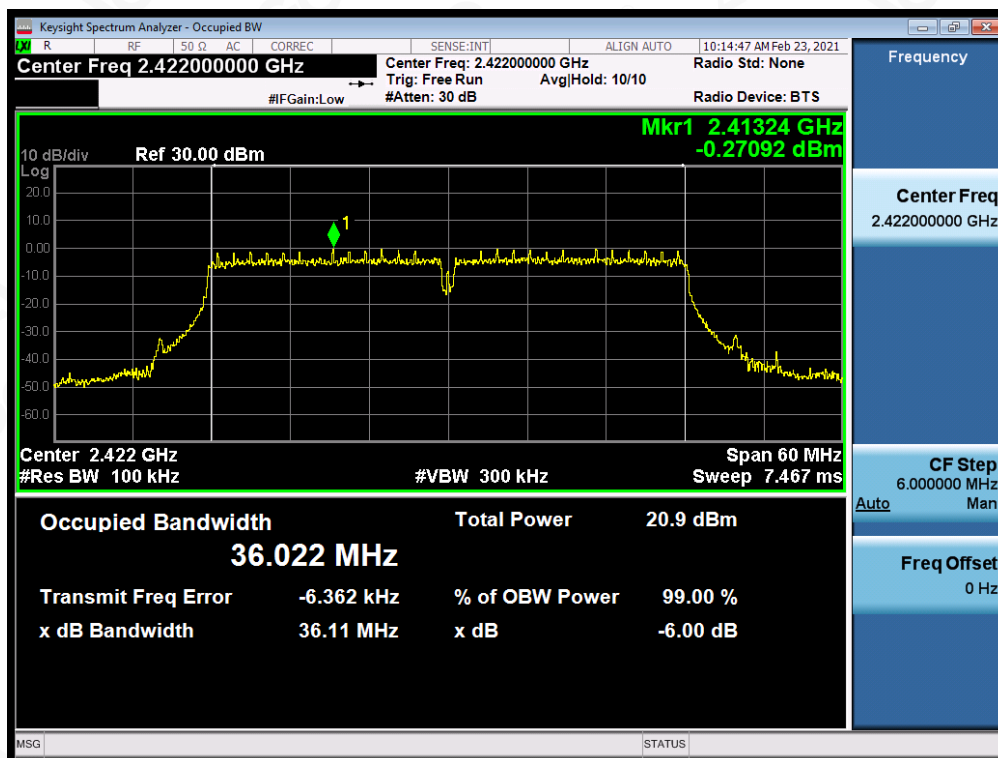


### TEST PLOT OF BANDWIDTH FOR HIGH CHANNEL

OF 802.11g FOR MODULATION IN MIDDLE CHANNEL



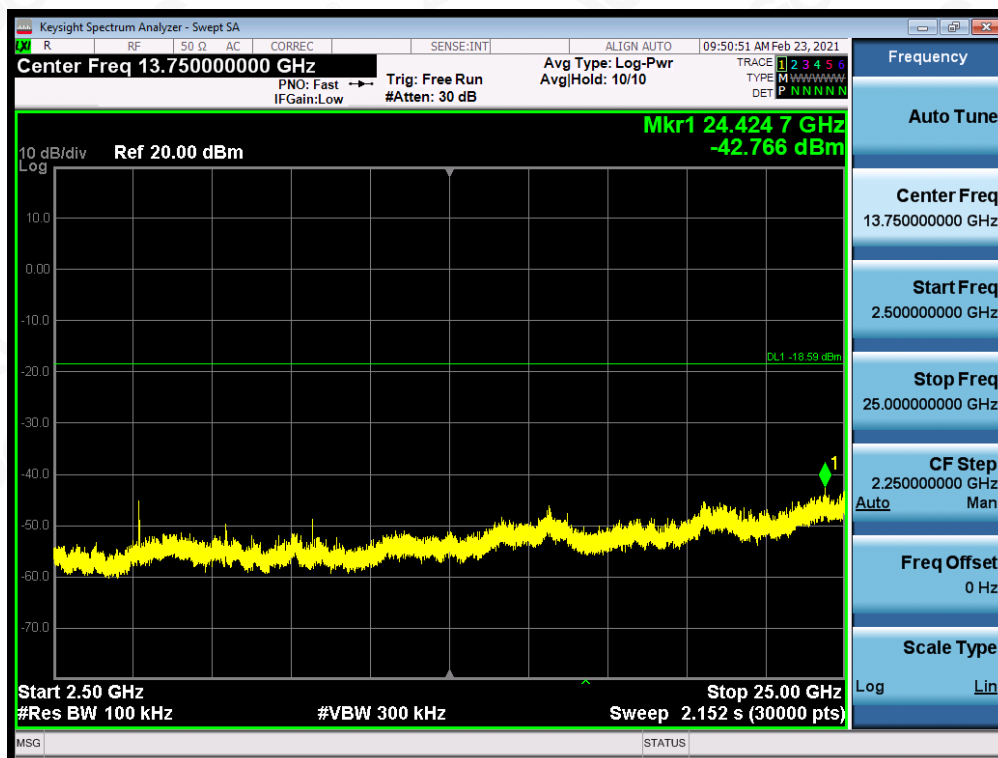
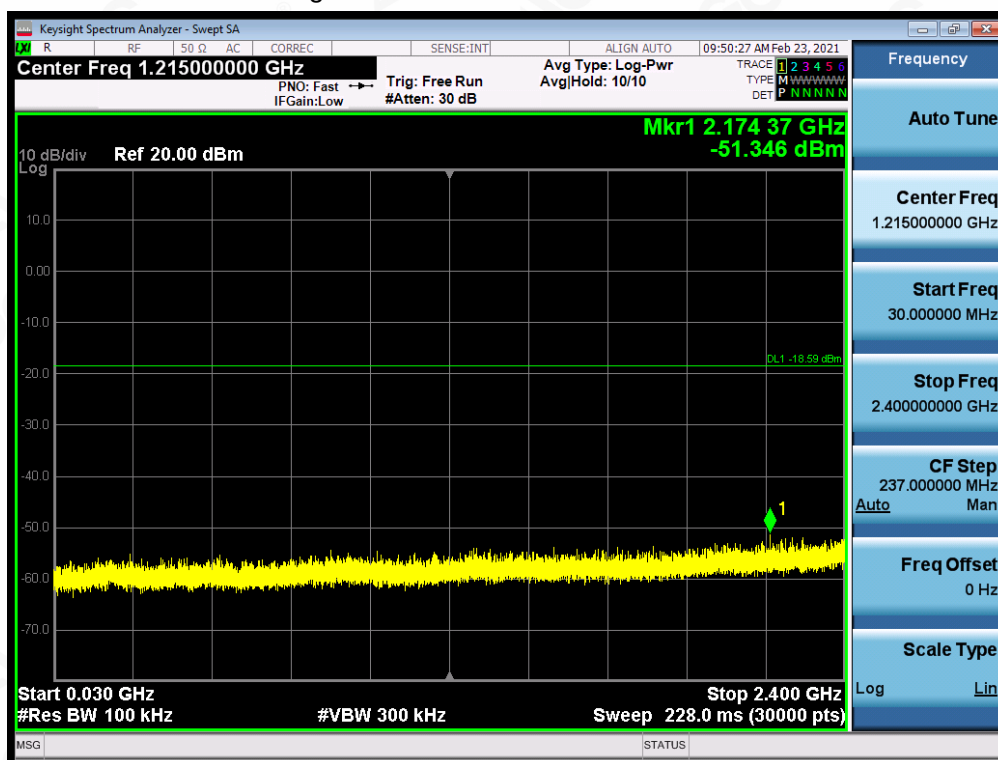

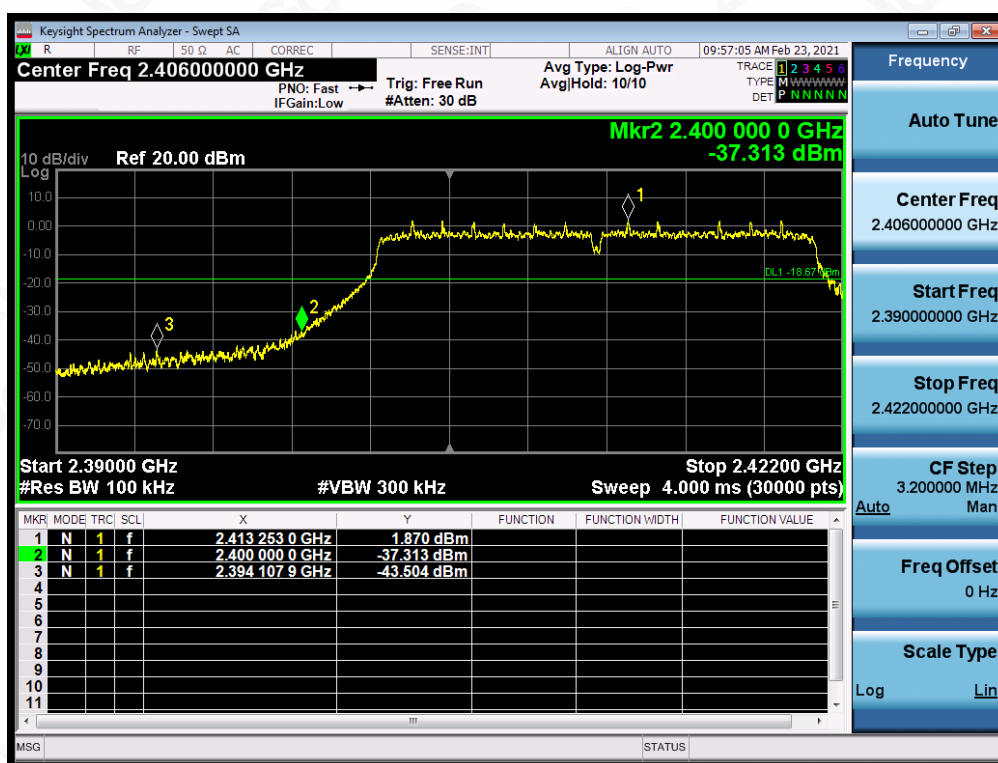
TEST PLOT OF OUT OF BAND EMISSIONS WITH THE WORST CASE

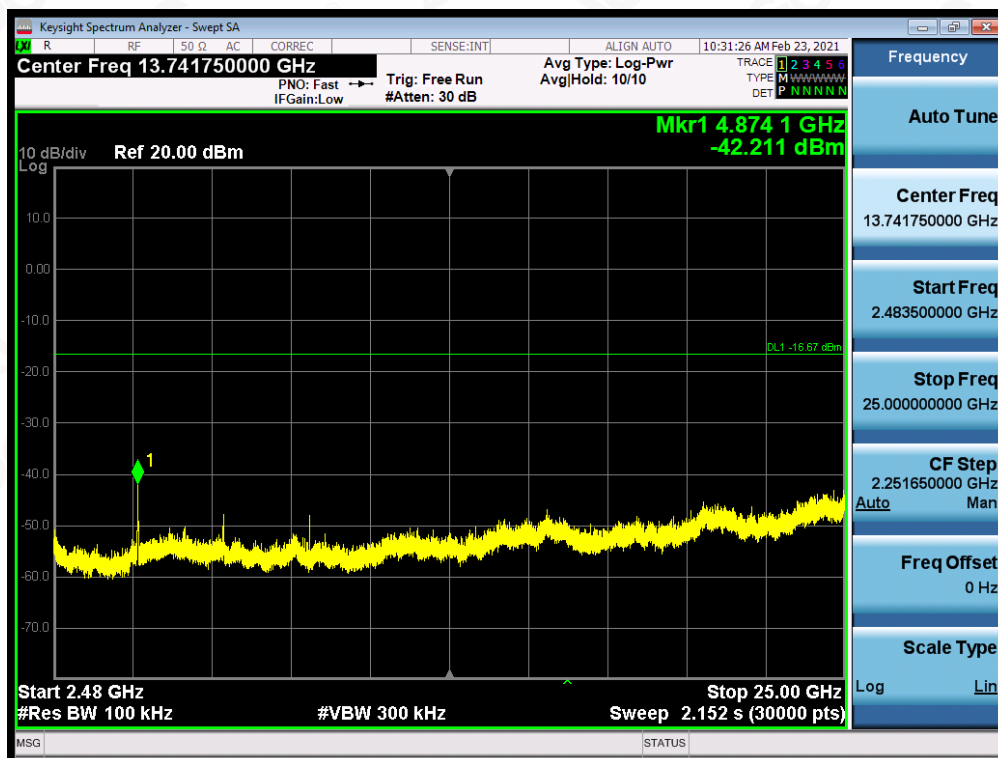
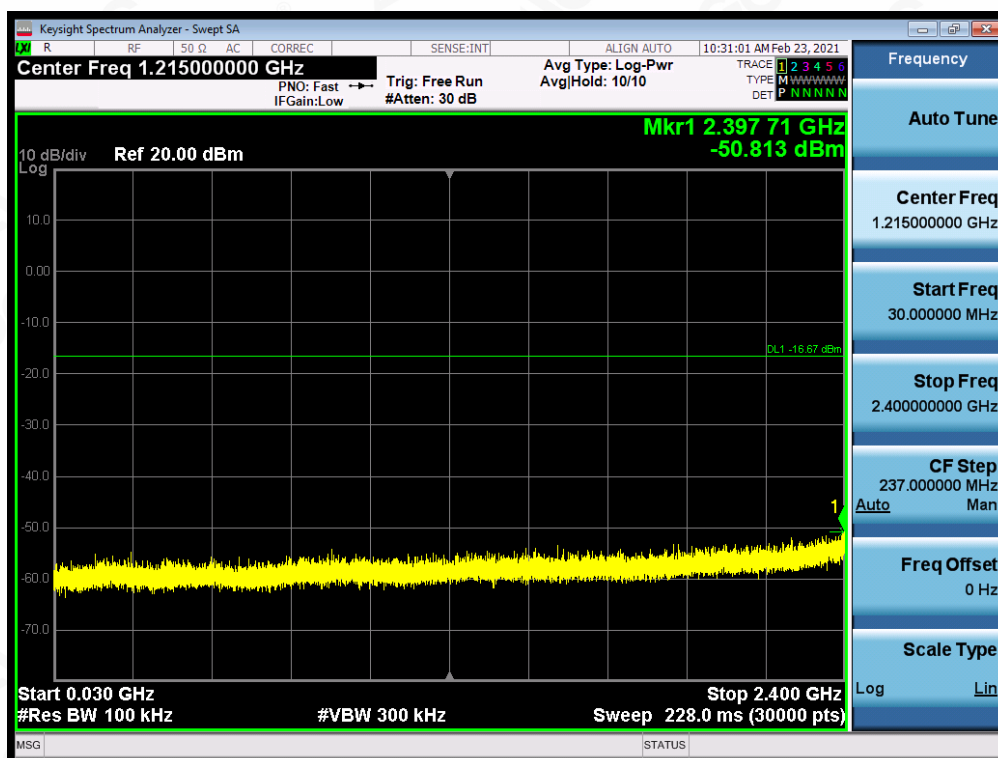

OF 802.11n20 FOR MODULATION IN MIDDLE CHANNEL



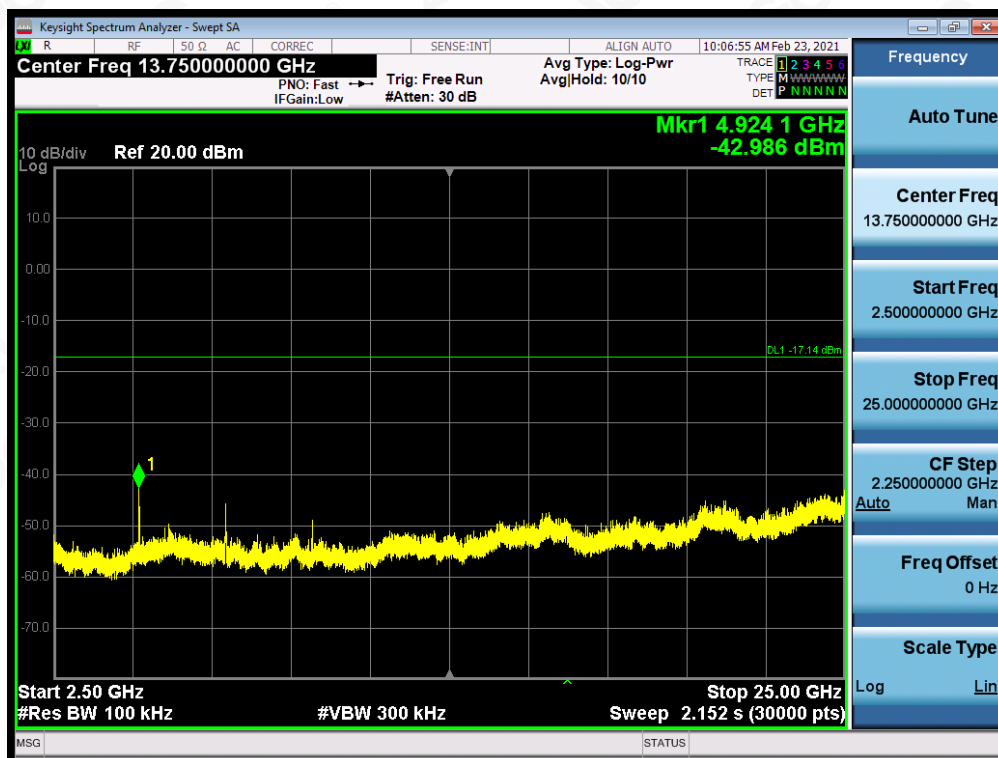
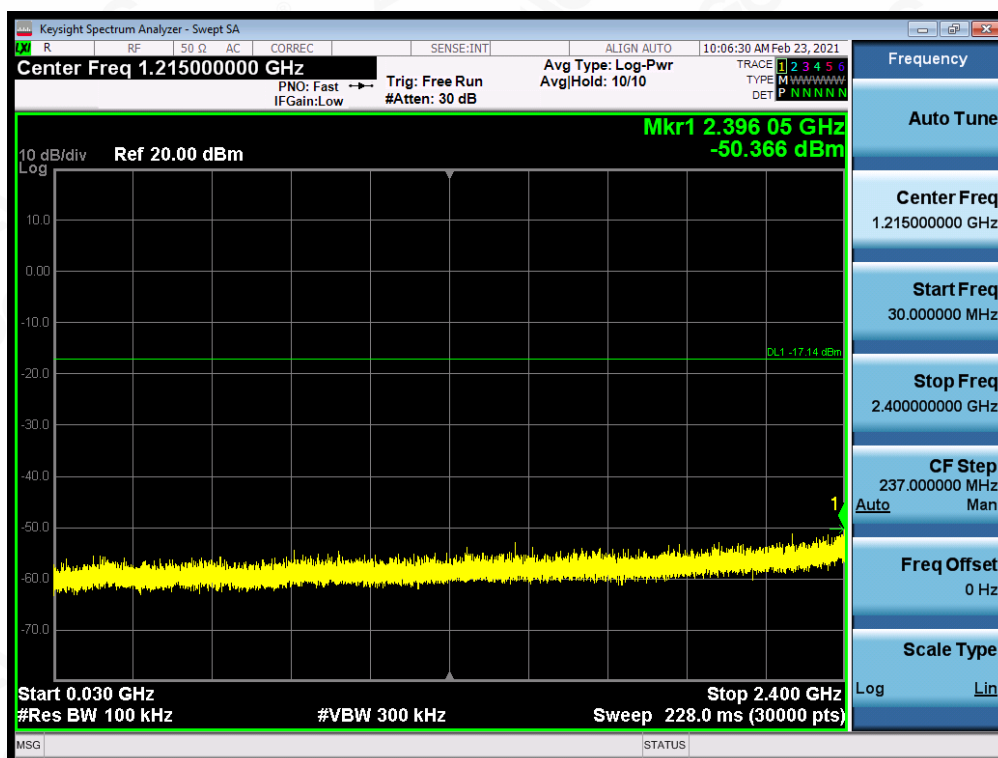

OF 802.11n20 FOR MODULATION IN HIGH CHANNEL

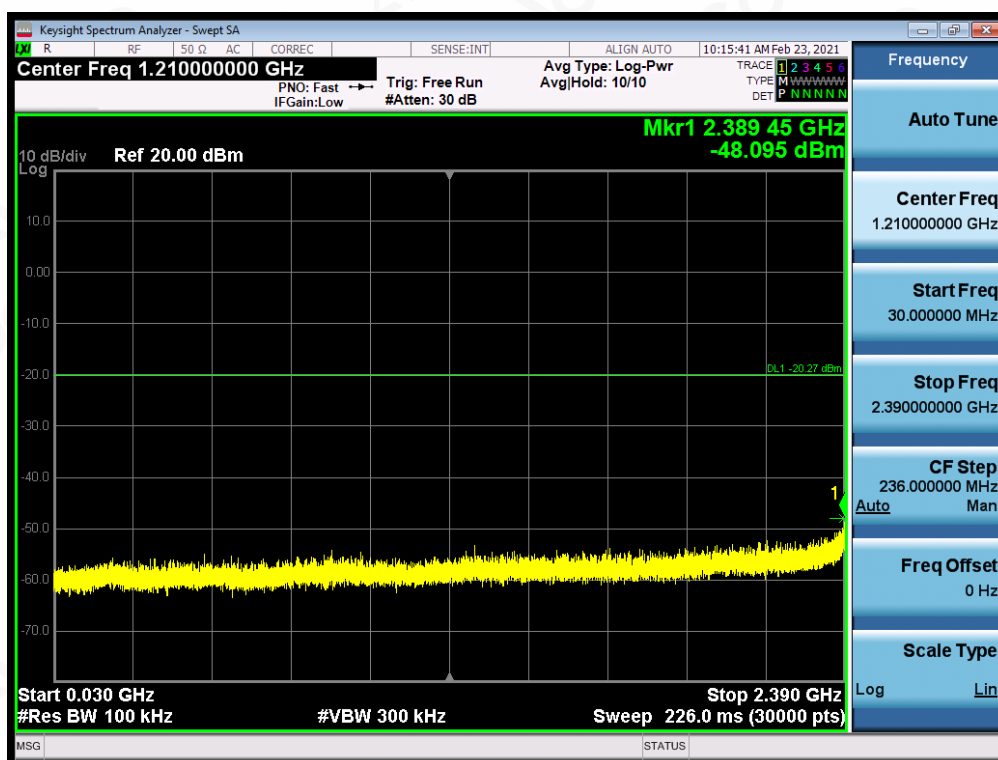

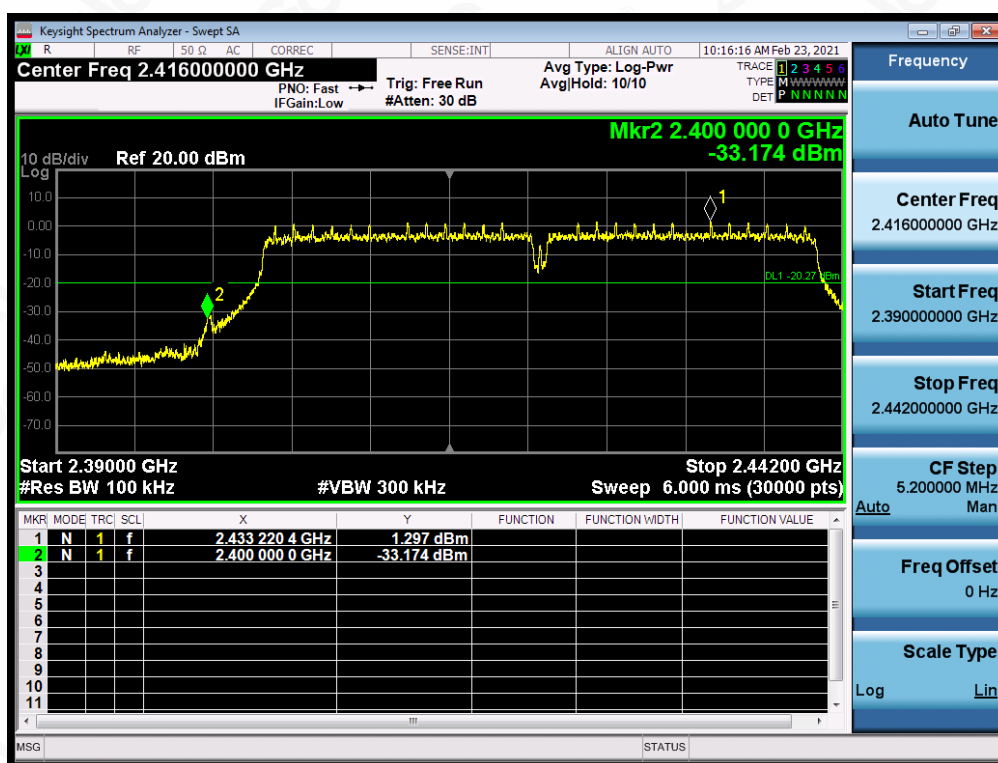

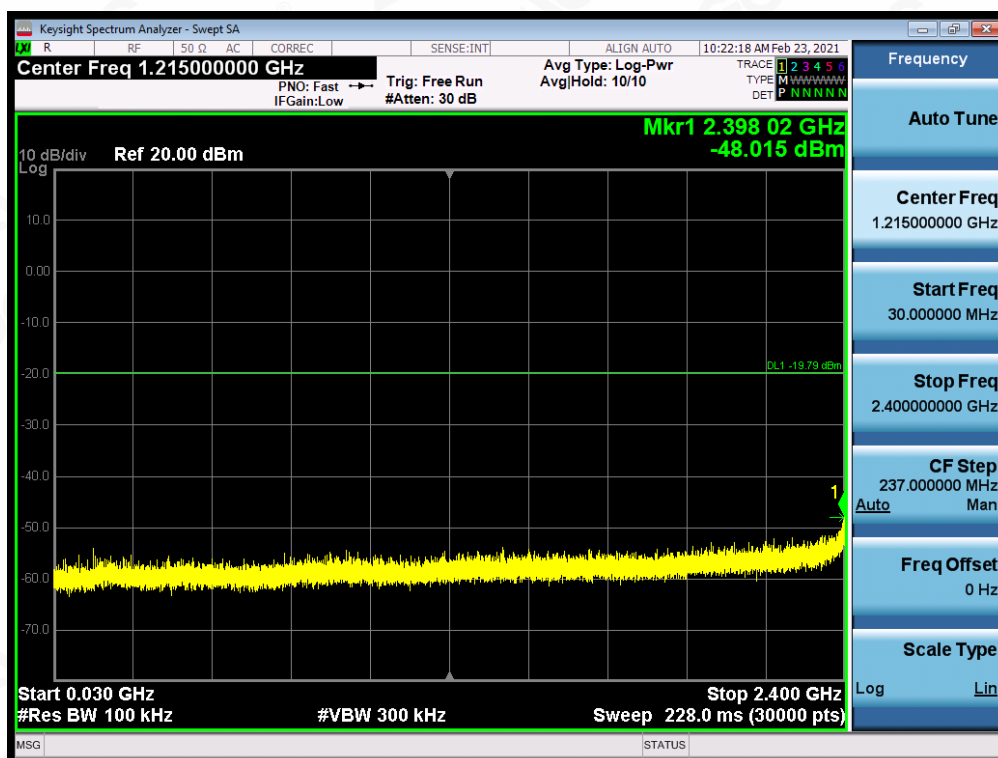

OF 802.11n40 FOR MODULATION IN MIDDLE CHANNEL



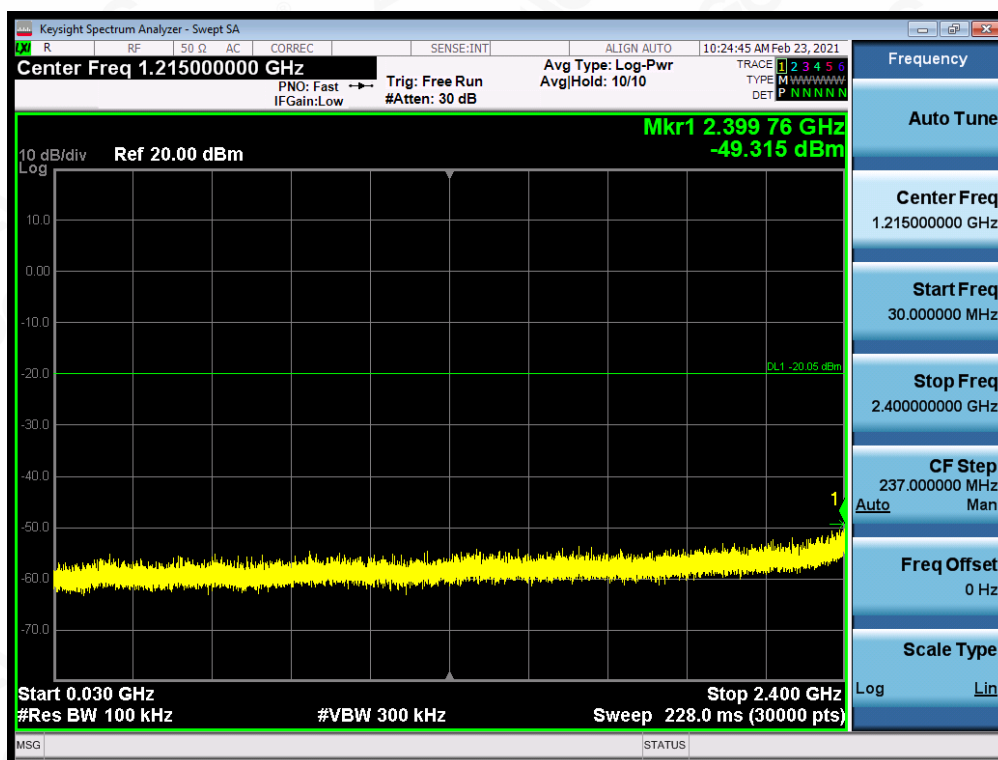

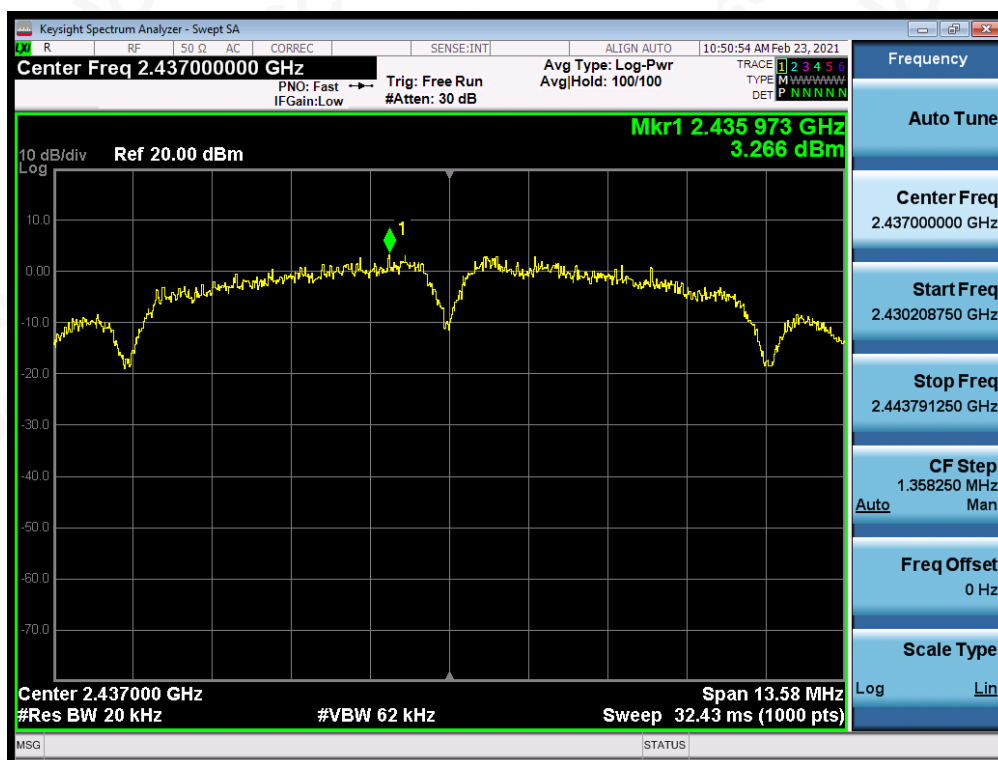

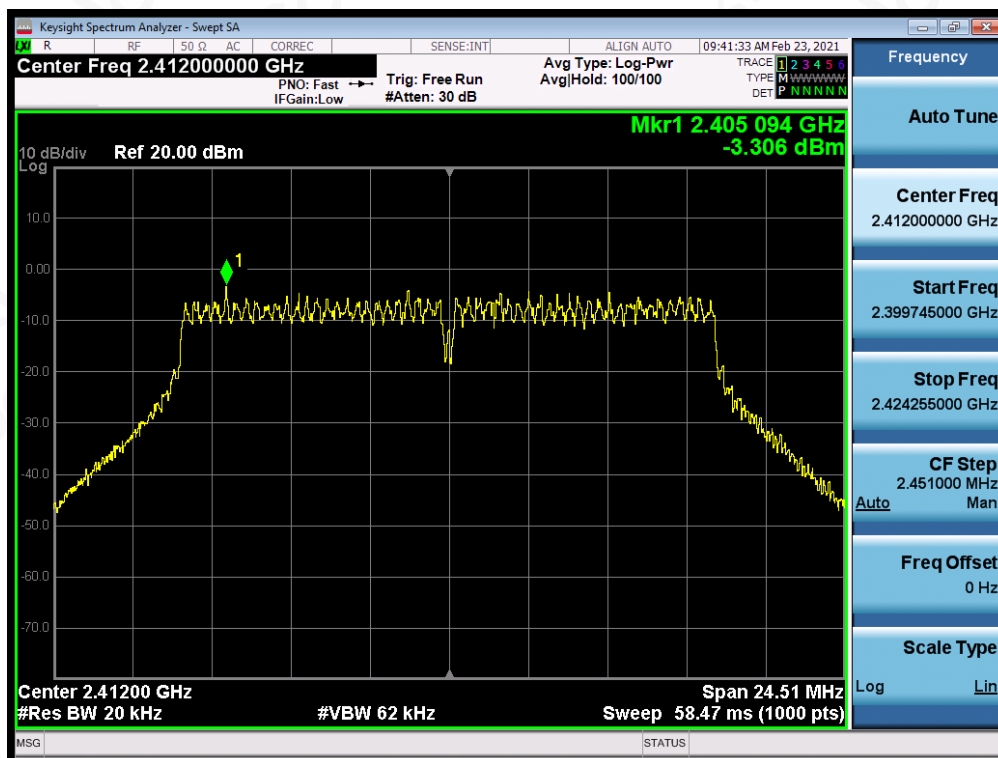


### TEST PLOT OF SPECTRAL DENSITY FOR HIGH CHANNEL
