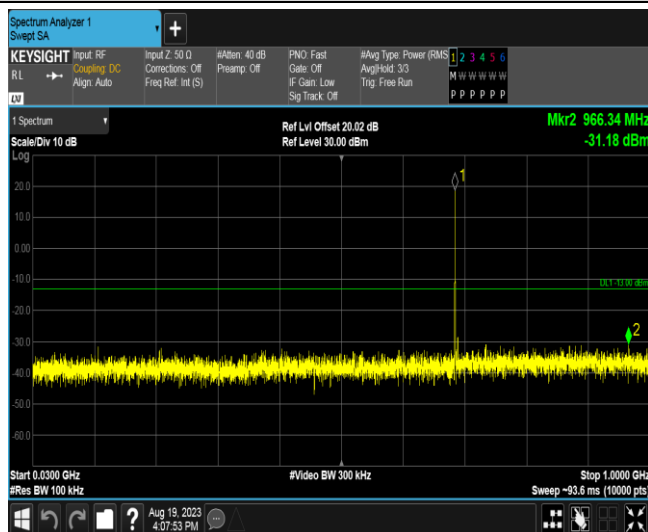

Band71-15MHz-16QAM-133297-1RB#0-Range1:30~1000MHz

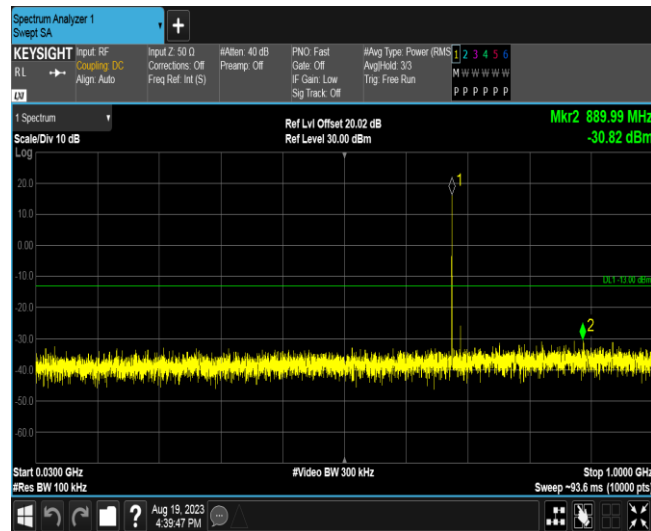


Band71-15MHz-16QAM-133297-1RB#0-Range2:1000~10000MHz

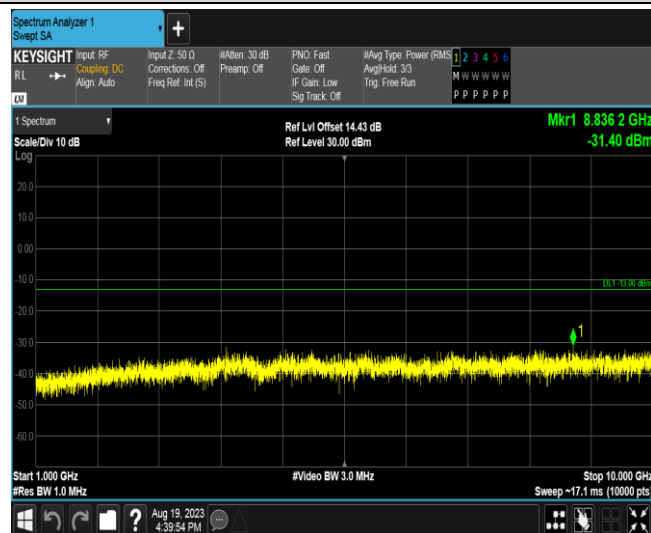

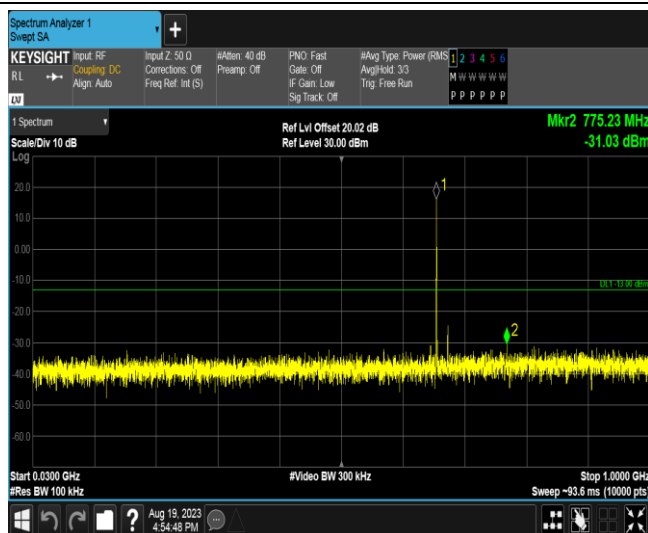

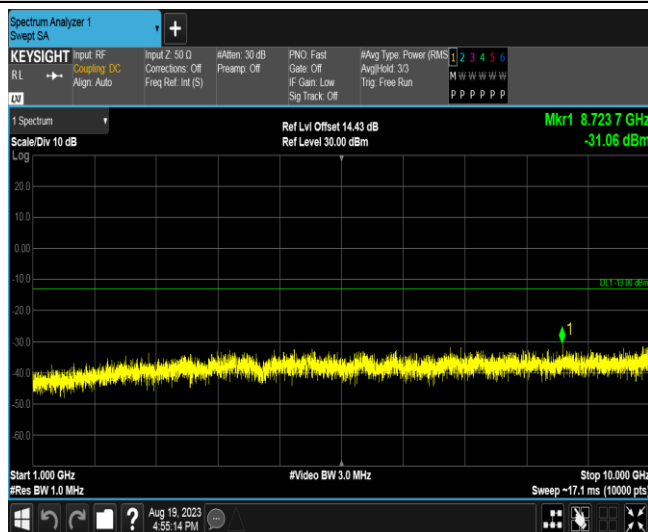
