The Manual also prominently displays the statements:

*Contains proprietary/trade secret information which is the property of Nokia and must not be made available to, or copied or used by anyone outside Nokia without its written authorization. Not to be used or disclosed except in accordance with applicable agreements.*

Exhibit 7 documents the internal views of the product that are not publically available and/or accessible to the public. These units are not only sealed but they are only located in non-public areas under direct control of the service provider.
