Per user manual, this device is a CRANE 2S. Based on 47CFR 2.1093, this device belongs to portable device category with General Population/Uncontrolled exposure.

Portable Devices:

47CFR 2.1093(b)

For purposes of this section, a portable device is defined as a transmitting device designed to be used so that the radiating structure(s) of the device is/are within 20 centimeters of the body of the user.

General Population/Uncontrolled Exposure:

47CFR 2.1093(d) (2)

Limits for General Population/Uncontrolled exposure: 0.08 W/kg as averaged over the whole-body and spatial peak SAR not exceeding 1.6 W/kg as averaged over any 1 gram of tissue (defined as a tissue volume in the shape of a cube). Exceptions are the hands, wrists, feet and ankles where the spatial peak SAR shall not exceed 4 W/kg, as averaged over any 10 grams of tissue (defined as a tissue volume in the shape of a cube). 4. RF Exposure Evaluation

> Standalone Transmission SAR Evaluation:

- According to KDB 447498 section 4.3.1, the 1-g SAR test exclusion thresholds at test separation Distances≤ 50 mm are determined by: [(max. power of channel, including tune-up tolerance, mW)/(min. test separation distance,
 - mm)]·[√f(GHz)] ≤ 3.0. • f(GHz) is the RF channel transmit frequency in GHz
 - Power and distance are rounded to the nearest mW and mm before calculation
 - \cdot The result is rounded to one decimal place for comparison
- 2. When the device is used, 5mm as the most conservative minimum test separation distance was used for evaluating.
