

- 1. Wireless Charging Mobile phones and other electronic devices:
- . Connect the built-in Type-C cable(1) to a power source. To achieve best performance, quick-charge power adapter is recommended.
- · LED indicator (4) will glow RED when the device is in wireless charging standby.
- · Place the wireless charging supported device on the wireless charging surface(2),
- . LED will glow BLUE when device is charging.
- . Phone will begin to charge automatically, ** Once fully charged remove the device. Note: When wireless charging, if the LED indicator flashes the device is either NOT a wireless charging device or there is an object between the device and charging
- surface interfering with the charging.
- 2. Wireless Charging a iWatch: . Be sure the wireless charging pad is
- connected to a power source. · Place the iwatch on the wireless charging surface(3) in the center groove of the wireless charging pad.
- . The watch will begin to charge automatically, the wireless charging LED(4) will glow BLUE when charging.
- . Once fully charged remove the device.
