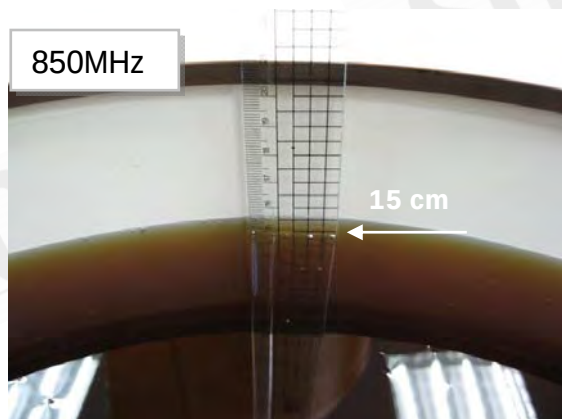

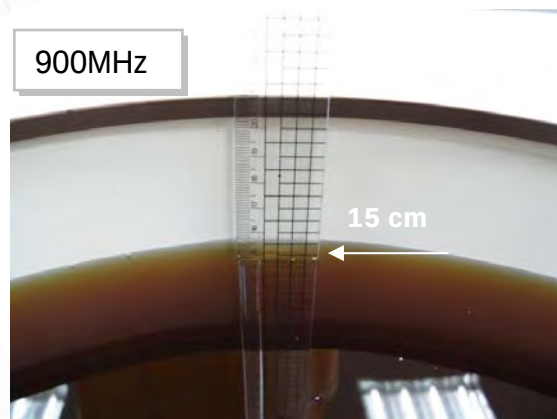

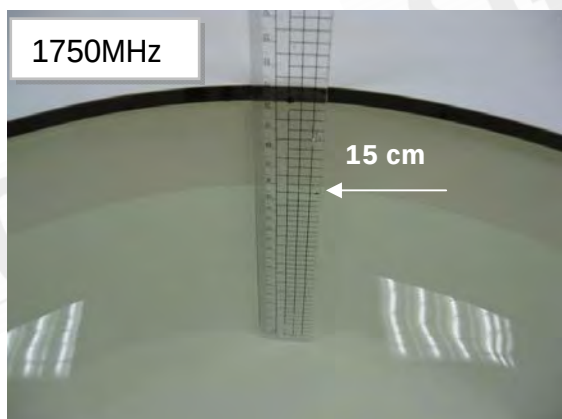

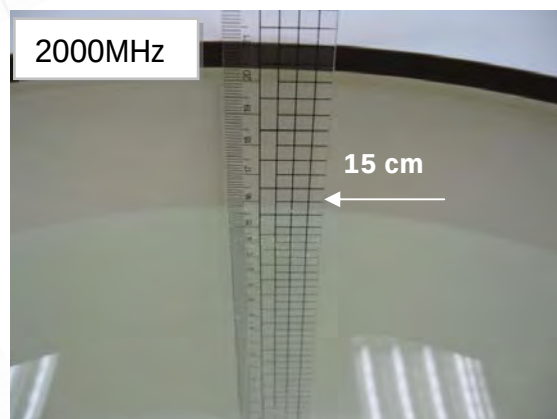

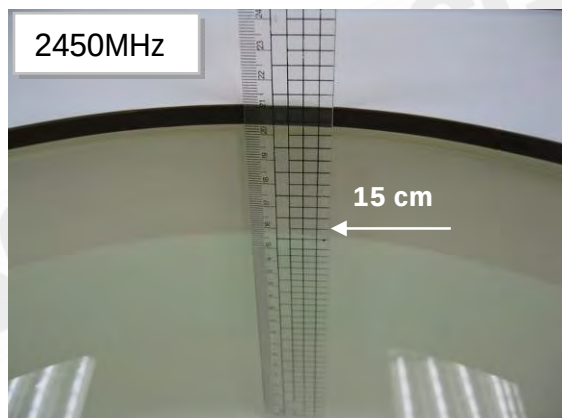

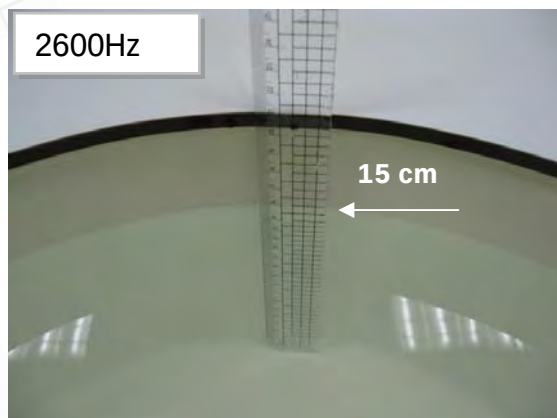

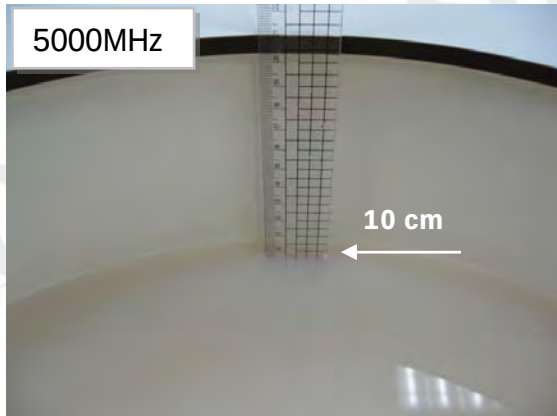

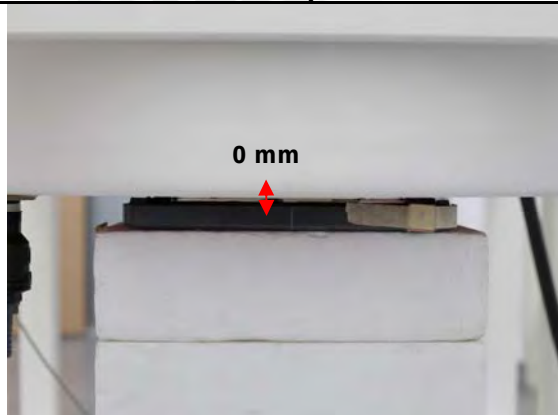


Fig.3 EUT Back side to flat phantom

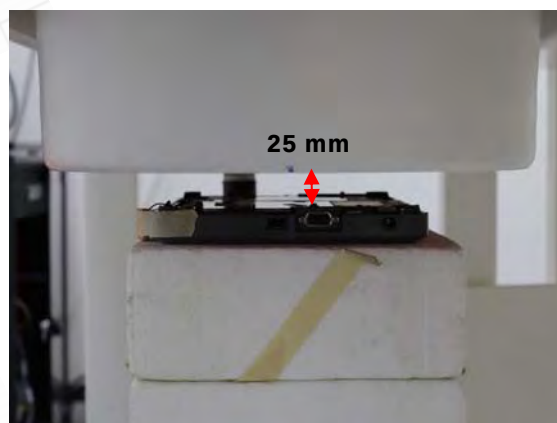


Fig.4 EUT Back side (25mm) to flat phantom

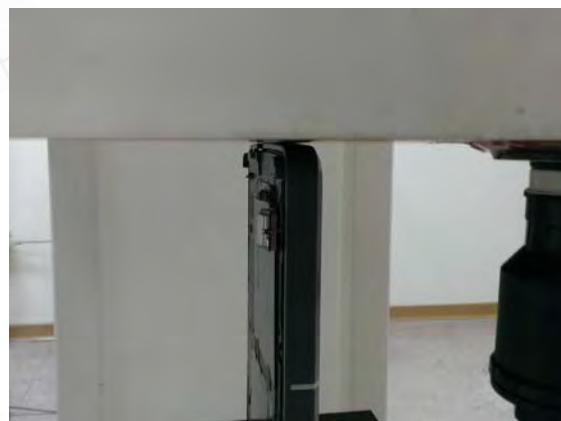

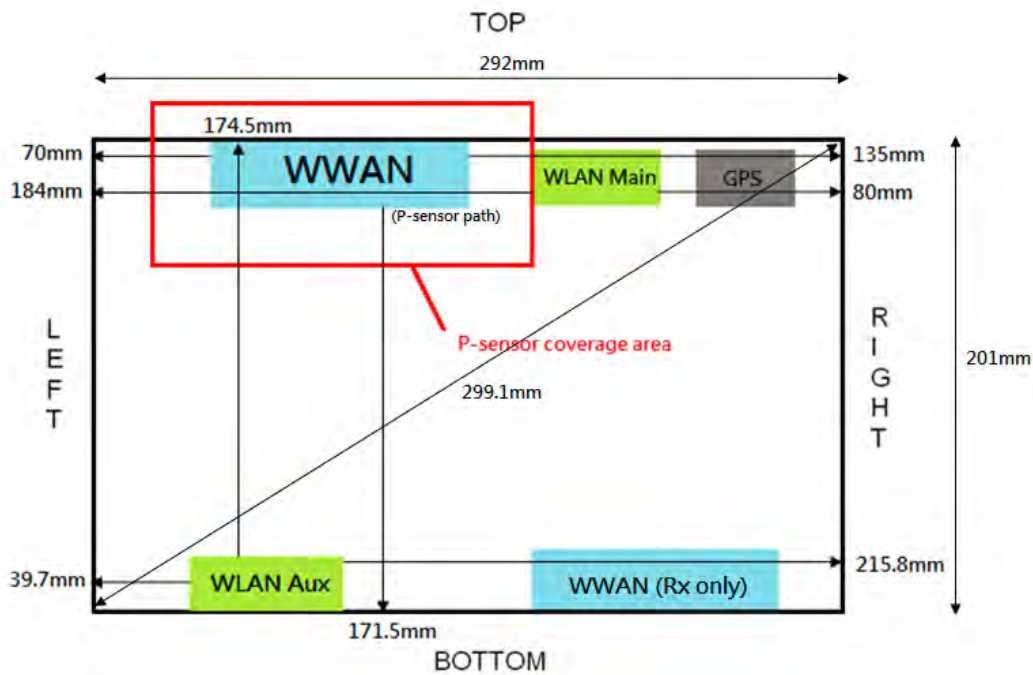


Fig.16 Antenna position of EUT (Front view)
