2. Antenna requirement

The antenna is a FPC antenna which permanently attached, and the best case gain of the antenna is 1.82dBi. It complies with the standard requirement.



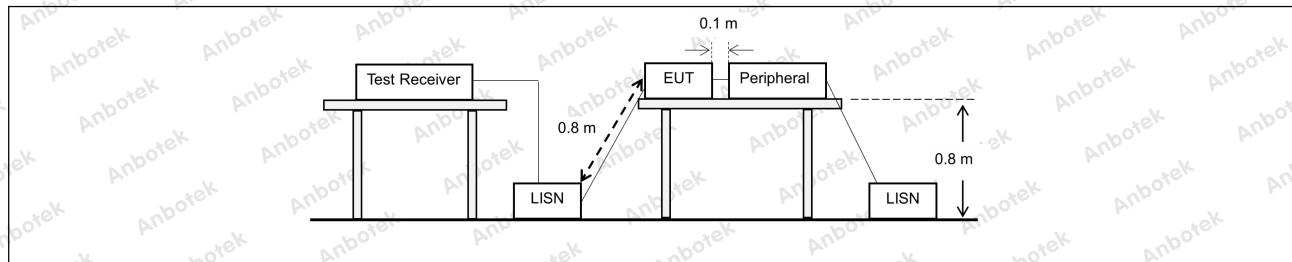
