



Switch Function Description

- 1. Power on / off: Long press the power button to switch
- 2. Mode Change: Short press the cycle button to change mode. (Multiple mode options: static red/static green/ static blue/static white/multi-color flashing/multi-color breat hi ng/red Breat hi ng/Bl ue Breat hi ng/Green Breat hi ng)



MODE+/ MODE-: Switch from static color to dynamic mode, or

bet ween dynamic modes. MODE+/ Previous MODE - / Next Mode

DEMO: Color cycle display mode.



#### NOTE

1. During use, if the switch can work normally, but the remote control cannot, you need to perform the code matching operation. 2. If the light is interfered by other remote controls or cannot be controlled remotely. Please power off and then power on again before performing code matching. How to perform code matching operation: Press and hold the start button on the remotecontrol for 3 seconds within 7 seconds of turning on the power, the light strip flashes 3 times with white light, indicating that the code (remote control) is matched.
