#### **Product Description for Equipment Under Test (EUT)**

#### Objective

This Type approval report is prepared on behalf of *Shenzhen Xinguodu Technology Co., Ltd.* in accordance with Part 2, Subpart J, and Part 15, Subparts A and C of the Federal Communications Commission's rules.

The objective is to determine the compliance of the EUT with FCC rules, sec 15.203, 15.205, 15.207, 15.209, 15.215 and 15.225.

#### **Test Methodology**

All measurements detailed in this Test Report were performed in accordance with ANSI C63.10-2013 "American National Standard of Procedures for Compliance Testing of Unlicensed Wireless Devices".

All emissions measurement was performed and Bay Area Compliance Laboratories Corp. (Dongguan). The radiated testing was performed at an antenna-to-EUT distance of 3 meters.





The setup of EUT is according with per ANSI C63.10-2013 measurement procedure. The specification used was with the FCC Part 15.207 limits.

The external I/O cables were draped along the test table and formed a bundle 30 to 40 cm long in the middle.

The spacing between the peripherals was 10 cm.

The adapter was connected to the main LISN with an AC 120V/60Hz power source.

#### **EMI Test Receiver Setup**

The EMI test receiver was set to investigate the spectrum from 150 kHz to 30 MHz.

#### **Test Procedure**

During the conducted emission test, the adapter or POE was connected to the outlet of the LISN.

The frequency and amplitude of the six highest ac power-line conducted emissions relative to the limit, measured over all the current-carrying conductors of the EUT power cords, and the operating frequency or frequency to which the EUT is tuned (if appropriate), should be reported, unless such emissions are more than 20 dB below the limit. AC power-line conducted emissions measurements are to be separately carried out only on each of the phase ("hot") line(s) and (if used) on the neutral line(s), but not on the ground [protective earth] line(s). If less than six emission frequencies are within 20 dB of the limit, then the noise level of the measuring instrument at representative frequencies should be reported. The specific conductor of the power-line cord for each of the reported emissions should be identified. Measure the six highest emissions with respect to the limit on each current-carrying conductor of each power cord associated with the EUT (but not the power cords of associated or peripheral equipment that are part of the test configuration). 





#### **EUT Setup**



The radiated emission tests were performed in the 3-meter chamber test site, using the setup accordance with the ANSI C63.10-2013. The specification used was the FCC Part Subpart C limits.

The spacing between the peripherals was 10 cm.

#### **EMI Test Receiver Setup**

The system was investigated from 9 kHz to 1 GHz.

During the radiated emission test, the EMI test Receiver was set with the following configurations:

The Corrected Amplitude is calculated by adding the Antenna Factor and Cable Loss, and subtracting the Amplifier Gain from the Amplitude reading. The basic equation is as follows:

Corr. Ampl. = Meter Reading + Antenna Factor + Cable Loss - Amplifier Gain

#### **Applicable Standard**

The frequency tolerance of the carrier signal shall be maintained within  $\pm 0.01\%$  of the operating frequency over a temperature variation of -20 degrees to +50 degrees C at normal supply voltage, and for a variation in the primary supply voltage from 85% to 115% of the rated supply voltage at a temperature of 20 degrees C. For battery operated equipment, the equipment tests shall be performed using a new battery.

#### **Test Procedure**

Frequency Stability vs. Temperature: The adapter under test was connected to an external AC power.

The EUT was placed inside the temperature chamber.

After the temperature stabilized for approximately 20 minutes, the frequency output was recorded from the Spectrum Analyzer.

Frequency Stability vs. Voltage: An external variable AC or DC power supply Source connected to the EUT or EUT adapter. Test the frequency output in the extremity voltage.

# FCC §15.215(c) – 20 dB EMISSION BANDWIDTH

#### **Applicable Standard**

Per FCC §15.215 (c) Intentional radiators operating under the alternative provisions to the general emission limits, as contained in §15.217 through § 15.257 and in Subpart E of this part, must be designed to ensure that the 20 dB bandwidth of the emission, or whatever bandwidth may otherwise be specified in the specific rule section under which the equipment operates, is contained within the frequency band designated in the rule section under which the equipment is operated. The requirement to contain the designated bandwidth of the emission within the specified frequency band includes the effects from frequency sweeping, frequency hopping and other modulation techniques that may be employed as well as the frequency stability of the transmitter over expected variations in temperature and supply voltage. If a frequency stability is not specified in the regulations, it is recommended that the fundamental emission be kept within at least the central 80% of the permitted band in order to minimize the possibility of out-of-band operation.

#### **Test Procedure**

Measure the frequency difference of two frequencies that were attenuated 20 dB from the reference level. Record the frequency difference as the emission bandwidth.


