# Chapter 1

## Overview

### The FlatMesh system

A FlatMesh network consists of a number of nodes connecting to one gateway device. In some situations, multiple networks may be required on a single site, for example a site in which the number of nodes exceeds the number supported by a single FlatMesh Gateway, or a site where there are a set of separate measurement zones. The Camera Hub will operate a

The Camera Hub is a fully integrated unit which provides all the functionality required to operate within a FlatMesh wireless sensor network in a remote location. This document describes the functionality of the Camera Hub only.

### FlatMesh Camera Hub

This device has an internal, rechargeable, Lithium-ion battery, which will last up to 3 weeks on one charge. Your Camera Hub will be provided with a power supply or solar panel to keep the internal battery charged.

The FlatMesh Camera Hub is Senceive's 3<sup>rd</sup> generation solar powered solution for static imagery in remote or industrial areas.

Building on the success of the Gen2 Camera and Edgehub combination, the Camera Hub combines the two devices into an all-in-one, purpose built, fully integrated, remote monitoring camera unit.

The Camera Hub boasts an upgraded monochrome digital camera capable of day or night photography without the use of external illuminators, high capacity (76.96Wh) rechargeable battery, crystal clear fixed focus lens, superior useability, and updated stylish looks.

## Chapter 2

### Installation

#### Pole / Stake Mounting

The Camera Hub will be delivered to you pre-configured. The Camera Hub is supplied with a rear fixing bracket which can be strapped onto a pole.



#### **WARNING:**

**The Camera Hub has a total approximate mass of 1.5kg. Please ensure that the object you are fixing to can support this load. Ensure that the appropriate methods and materials are used when affixing equipment to a wall.**

The Camera Hub should be installed with the 2 No. LTE antennae uppermost, and the FlatMesh 2.4GHz antenna aligned downwards. This is key to ensuring the best radio performance for both the FlatMesh network and for the cellular connection.




## Pole / Stake Installation



**The stake /pole needs to be mounted and set in the ground before beginning installation of the Camera Hub**  
**You need to ensure you have received permission and follow site regulations before installation.**

The Camera Hub will be a part of a wireless network and needs to be in communication range of its host FlatMesh Gateway.

1. Identify the safe location for the Camera Hub to be installed to obtain the required photographs of the target zone as displayed in the Camera Hub photograph opposite.	
2. A C.A.T scanning operative needs to scan the proposed position to ensure it is safe to break ground.	 <b>BE SAFE!</b>
3. Measure and mark the depth of how deep the stake/ pole needs to be hammered into the ground.	
4. Hammer the stake/pole ensuring it is as straight as possible. 5. Check the stake/pole is firmly installed and does not move freely.	



**If installing a Pole it is important to ensure the post concrete is completely set before beginning installation. This is to avoid the pole leaning once everything has been installed.**

## Camera Hub Installation on the Pole/Stake.



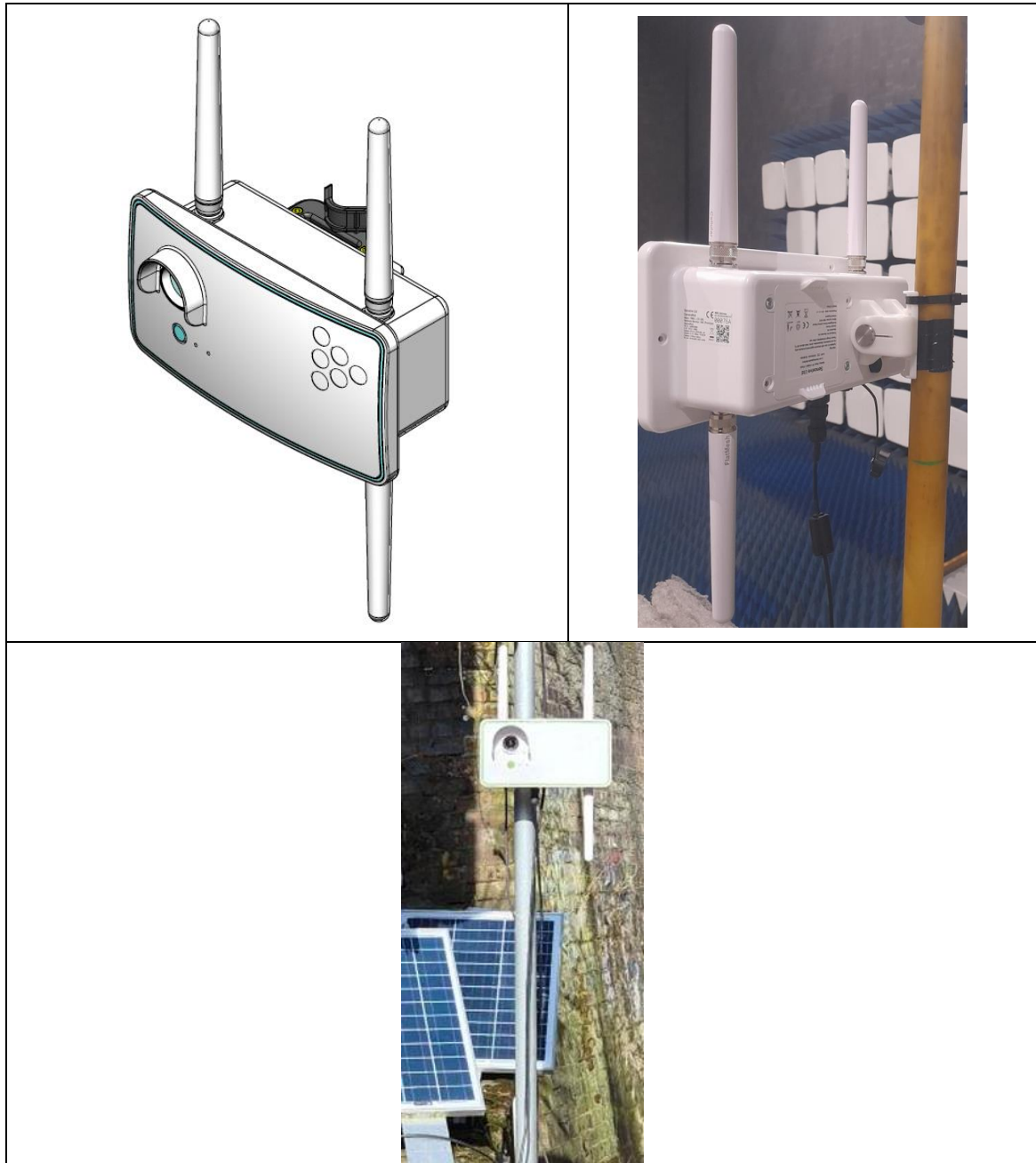
**Figure 2.1: Camera Hub Rear Bracket for Pole Mounting**

1. Loosen the Jubilee Clip metal banding supplied using an 8mm socket.
2. Thread the Jubilee Clip metal banding through the mounting slot on the back of the Camera Hub pole mount bracket.
3. Align the Camera Hub for the camera to view the target photograph area and thread the Jubilee Clip metal banding over the stake /pole.
4. Tighten the Jubilee Clip metal banding around the stake /pole using an 8mm socket until the Camera Hub is fixed rigid to the stake /pole.
5. Strongly tighten the 2x vertical adjustment hex screws using the 4mm hex key.



**Do Not over-tighten the Jubilee Clip metal banding as this could damage the Camera Hub pole mount plastic bracket.**

6. Align and attach the provided 2 No. Cellular Antennae on the top of the Camera Hub and the 2.4GHz FlatMesh radio antenna on the bottom of the Camera Hub and tighten by hand.
7. Affix the Solar Panel to the pole to the manufacturer's instructions and connect the power supply cable from the Solar Panel to the Camera Hub power input connector next to the 2.4GHz FlatMesh radio antenna on the bottom of the Camera Hub.

## Power

The Camera Hub has an internal Lithium-Ion battery pack which when fully charged will allow the device to operate for 2-3 weeks.

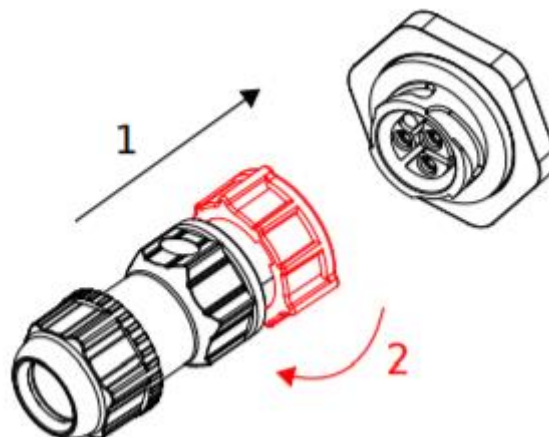
For continued operation, you will have been supplied with a solar panel or mains AC/DC PSU power supply (for indoor use).

The three-pin power input connector can be found at the bottom side of the unit, to the left of the 2.4GHz FlatMesh antenna.

Engage the power connector and turn the collar to lock in place, as displayed below.

## Antennae

There are three distinct antennae which must be connected to the correct N-type sockets on the device.

The antenna/socket pairs are labelled **Cellular (x 2)** on the top of the Camera Hub, and **FlatMesh** on the base of the Camera Hub.

### Check

It is very easy to accidentally cross-thread the antenna connection. Be sure to align the connectors properly before screwing together

The Antenna types for use with this device are as described below:

- The maximum gain of the FlatMesh antenna that is permitted to be used with the device is a +3.4dBi, 50ohm dipole for the 2.4GHz radio.
- The 2.4GHz FlatMesh radio FM3Nano PCB will be connected to the supplied:
  - OS-ISMDB-0507-C0 antenna, (+3.4dBi gain in 2.4GHz range).
- The cellular module shall be used with the 2 No. supplied:
  - OS-LTE-11-C0 antennae. (one of which is connected as a diversity, receive only antenna).

## Ethernet Access Port

The Camera Hub provides an Ethernet connection port socket for attachment to a Host device, which can either be a personal computer or a tablet. This port is envisioned for installation and device setup (still in the product development stage).

The Ethernet connection access port is located on the bottom of the Camera Hub next to the power connector. Unscrew the attached black plastic cover (by hand, if possible, to avoid damage), to access the Ethernet connection port for data transfer.



**Figure 2.6: Ethernet connection point on the Camera Hub**

When finished with the Ethernet Access Port, disconnect the ethernet cable, remove the cable and replace the black plastic cover. Tighten the black plastic cover cap until it is hand tight.

## Chapter 3

### Maintenance

The product requires minimal maintenance after installation.

It is recommended that the lens should ideally be cleaned once every 2 years.

If the need to clean the exterior of the product should arise, use only a damp cloth and mild detergent.

Do not use any solvents as this may damage the enclosure.
