GENERAL INFORMATION

Product Description for Equipment under Test (EUT)

The *Sky Phone LLC*'s product, model number: *SKY5.0W* (*FCC ID: 2ABOSGCSKY50W*) or the "EUT" in this report was a *Mobile Phone*, which was measured approximately: 143 mm (L) x72 mm (W) x 9 mm (H), rated with input voltage: DC 3.8 V rechargeable Li-ion battery. The highest operating frequency is 1300 MHz.





The EMI test receiver was set to investigate the spectrum from 150 kHz to 30 MHz.

During the conducted emission test, the EMI test receiver was set with the following configurations:

Test Procedure

During the conducted emission test, the host PC was connected to the first LISN and the other relevant equipments were connected to the second LISN.

Maximizing procedure was performed on the six (6) highest emissions of the EUT.

All data was recorded in the Quasi-peak and average detection mode.

The Corrected factor is calculated by adding LISN/ISN VDF (Voltage Division Factor), Cable Loss and Transient Limiter Attenuation. The basic equation is as follows:

Correction Factor = LISN VDF + Cable Loss + Transient Limiter Attenuation







Test Procedure

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

All data was recorded in the Quasi-peak detector mode from 30 MHz to 1 GHz and PK and average detector modes for frequencies above 1 GHz.
