#### **Objective**

This test report is prepared on behalf of *Hyundai Corporation in accordance* with Part 2-Subpart J, Part 15-Subparts A, B and C of the Federal Communication Commissions rules.

The tests were performed in order to determine compliance with FCC Part 15, Subpart C, section 15.203, 15.205, 15.207, 15.209 and 15.247 rules.

#### **Test Methodology**

All measurements contained in this report were conducted with ANSI C63.4-2009, American National Standard for Methods of Measurement of Radio-Noise Emissions from Low-Voltage Electrical and Electronic Equipment in the range of 9 kHz to 40 GHz.

All emissions measurement was performed at Bay Area Compliance Laboratories Corp. (Shenzhen). The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

Measurement uncertainty with radiated emission is 5.91 dB for 30MHz-1GHz, and 4.92 dB for above 1GHz, 1.95dB for conducted measurement.









## BDR (GFSK): Band Edge-Left Side



EDR ( $\pi/4$ -DQPSK): Band Edge-Left Side




## EDR (π/4-DQPSK): Band Edge-Right Side

## EDR (8DPSK): Band Edge-Left Side


