





Assembly


1.Install the 2 RTK antennas to the holders and connect the feeders.




2.Install the main body of the base station to the tripod and tighten the screws on the tripod.



3. Align the red dots on the 2 RTK holders with the white mark on the main body of the base station and insert the holders in place; Tighten the screws at the joint and conect the feeders to the N-type connectors; Install the omnidirectional antenna to the bracket according to the instruction on the sticker.



4.Insert the batteries and close the battery compartment.




Power On/Off


- 1.Press the power button until you hear a "beep", and the power indicator turns solid green, indicating that it has been turned on.
- 2. Press the power button until you hear 10 beeps, and the power indicator turns off, indicating that it has been turned off.

Link the base station to the aircraft

1. Short press the linking button on the base station, and the linking indicator will flash green quickly.



2. Short press the linking button in the battery compartment of the aircraft, and the linking indicator will flash green quickly.



 Once linking is successful, the linking indicators both on the base station and the aircraft will flash green slowly.

Link the ground station to the base station

- 1.Turn on the ground station and run the Autel Voyager App, select "Settings -> Base Station". You will see the base station WiFi/hotspot, then enter the password 12345678. Once linking is successful, the WiFi indicator will be solid green.
- 2. Back to the "Settings" menu, click "Remote Control", and turn on the "use base station connection" option.
