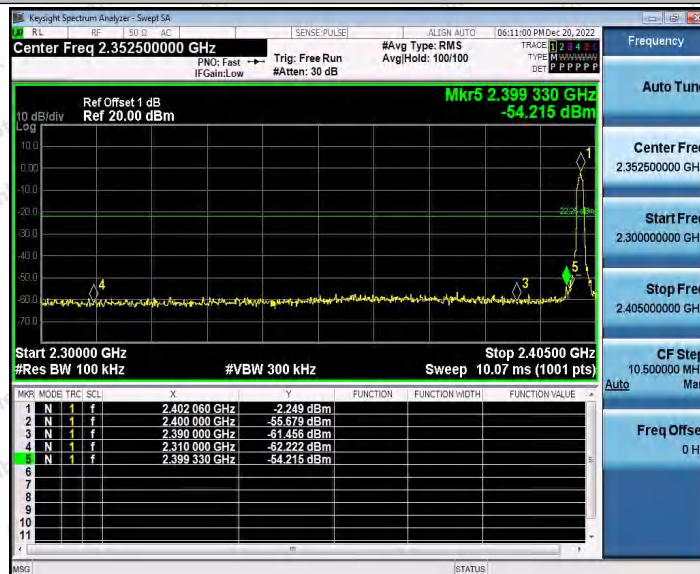




DH5_Ant1_High_Hop_2480
