


6. Spurious Emission at Antenna Terminal

Remark1: For the averaged unwanted emissions measurements, the measurement points in each sweep is greater than twice the Span/RBW in order to ensure bin-to-bin spacing of $< \text{RBW}/2$ so that narrowband signals are not lost between frequency bins.
