7. Evaluation Result

As declared by the Applicant, the EUT is a wireless device used in a fix application, at least 20 cm from any body part of the user or nearby persons; from the maximum EUT RF output power, the minimum separation distance, $r = 20 \, \text{cm}$, as well as the gain of the used 2.4GWIFI antenna is 2.07dBi, the RF power density can be obtained.
