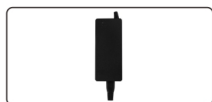

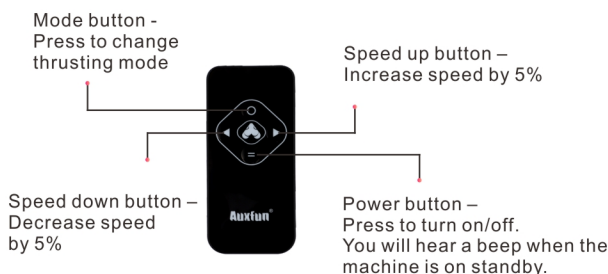

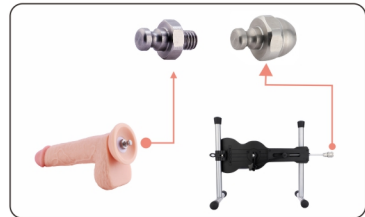

3.When the part is in, you can use it with your Auxfun sex machine, or screw it off to use it as a regular suction cup dildo.



Note:

1. When you press the Mode button, the machine will cycle through the preset thrusting modes. There are 8 modes to choose from.
2. If you press the Mode button first, then press one of the speed buttons, the machine will go to its basic speed.
3. Each time you press either speed button, the speed will change by 5%. Please pay attention to safety during use.

Recommendations

1. Pay attention to hygiene, and wash all attachments before and after use.

3. Before storing, loosen the stroke length adjusting knob, unplug the power cable and clean the machine as well as the attachments. Store in cool and ventilated area.

2. Please don't hold or force back the thrusting bar while the motor is running. This can shorten the lifespan of the motor.
3. Please do not sit or lean on the machine with your full weight. It is built to withstand a maximum of 100 kilograms of force.
4. It is normal for the machine to get warm/hot during continuous usage. Please do not use the machine longer than 60 minutes in one session.
