





- 2. 将具有无线充功能的手机、耳机置于产品的左边 充电板,则左边绿灯单个亮起,反之;以上皆为正常 充电; 当指示灯不亮时, 为充电异常, 请重新调整手 机摆放位置,待指示灯只显示绿色。
- 3. 充满电后,绿灯长亮5秒后熄灭。
- 注:目前只有三星手机支持满电反馈,其余手机充 满电后充电板不作任何提示。







- 2. Put wireless charging mobile phone on the left of the charger, the left green light will light up individually vice versa. All of the above are normal charging. When the indicator is off, the charging is abnormal. Please adjust the position of the phone again untill the indicator light only displays green.
- 3. After full charge, the green light will turn off after 5
